He started by working tirelessly as an engineer, head of the engineering department, technical director, vice president and the President of the Construction division. Then, as the founder of the Construction Unit, he earned the honour of being the General President of the Construction Unit at the Ministry of Education in Kabul.

Ahmed Afghan has been the project coordinator for school buildings and similar projects financed by UNESCO, UNICEF, WFP, World Bank, and USAID in the Ministry of Education in Kabul. He was appointed Consul General of Afghanistan in Bombay, India, where he served from 1981 to 1985.

While living in India, Afghan continued working on his goal of establishing peace in his motherland, Afghanistan. He and his family settled in Vancouver, B.C., Canada, in Sept 1987, where he now continues to work toward his dear and critical goal of seeing a free and prosperous Afghanistan.

PREFACE

After graduating from the engineering faculty in 1964, I joined the Ministry of Education. It was my hope and passion to build schools for the sons and daughters of my beloved country while utilizing various internal and external sources of financial assistance.

I accomplished my dreams and ambitions with encouragement from my superiors and persistent hard work. Unfortunately, after the bloody coup d'etat in April 1978, everything changed. I was fired from duty as the president of the construction unit on the grounds of being in the United States and Canada to pursue my practical training and higher education (MSc). I also had financial assistance from Western governments and organizations to construct school buildings, which was another factor against me.

However, after two months, I was officially invited by UNESCO's Regional Office for Education in Bangkok, Thailand, to join the regional conference. They requested me to attend the conference and speak about my educational building report under "Innovation in the Management of Primary School Construction in Afghanistan." With this invitation, I was appointed as the general director of school mapping in the Ministry of Education planning division so I could attend the conference officially.

After the unjustified and bloody invasion of my motherland, Afghanistan, by the Soviet Union in December 1979, I was under the strict supervision of communist spies, and all the external financial assistance I had worked hard to construct school buildings frozen. Most of the existing schools and the schools under construction have been destroyed, leaving the children with no means of gaining education

Therefore, Dr. Anahita Ratibzad, the new minister of education, ordered me to return to the construction unit and start my work again. Furthermore, she asked me to try and re-encourage

the inflow of foreign assistance for the education sector. Since it was an order, I had no choice but to accept the job, despite initially rejecting it reluctantly.

However, an incident soon made me realize the severity of losing our sovereignty as a nation and as individuals.

One day, I went to the minister's office for some instructions. While I waited outside the office for permission to enter and meet her, a Russian adviser barged into the office without permission and left after a few minutes. I was pretty bewildered watching this unfold. After I got the opportunity to enter the minister's office and sit with her at the meeting table, the same Russian adviser entered, again without asking for permission, to ask for a document.

He said, "Comrade Anahita, where is that letter?" She replied that it was somewhere on her office desk, and the Russian adviser ignored all mannerisms or official protocols, going behind her desk to search for the letter. He opened and closed her private drawers until he found what he was looking for.

Then, without thanking or bidding the minister farewell, he left the office. That was the second blow to my head.

While I was sitting with the minister, a telephone call came from the head of the third political division in Istiqlal High School. The person on the phone said to the minister, "Comrade Anahita, I nominated one person as the President of Physical Education, and you have appointed someone else. What is the reason behind this?"

The minister replied, "Dear Comrade, those times have passed. Now, we can't put our steps forward without the permission of our Russian comrades. The Russian advisor has directly nominated the person to me," and the conversation ended.

To make matters worse, I met a Tajiki Persian translator who I knew from the planning office after leaving the minister's office. He asked me about my whereabouts and mentioned that he had not seen me for quite some time in the planning office. I told him that I had been reassigned to the construction unit, to which he immediately nodded, detailing how they had approved my assignment. That was the third blow to my head since everyone knew me, from President Babrak Karmal down to Dr . Anahita, but they still needed the Russians' permission for my reappointment. An extreme feeling of subservience had started to engulf me.

In October 1980, I received a letter from the Ministry of Planning asking for an updated and detailed progress report for constructing schools in the country. As soon received, the letter responded with some factual information to the Minister of Planning, mentioning that Mujahideen had destroyed most of the schools; Moreover, in most provinces, the money for school construction had been robbed from the banks by the so-called Mujahideen. Roads are also closed, and nobody would dare go to the site of schools. Therefore, how could I give a progress report? I sent copies of the same letter to the Minister of Education and the Minister of Finance.

When the Minister of Finance and his Russian adviser read my response and found that I had exposed the facts about the country, they got nervous. The Minister of Finance called me and said that a Russian adviser would come to meet me. Russian adviser from the Ministry of Finance came to my office and inquired about my letter addressed to the Ministry of Planning and Finance. He wanted to know who had written this letter so he could 'get rid of him.

Infuriated, I thumped the table with my fist and said that the Finance Minister told me he was sending me an adviser and not an executioner. Unable to withstand another blow that day, I got up from the meeting and left the room to return to my office.

After reality had wholly sunk in, I told myself that this country was not mine anymore. Though I had already applied for a position in the World Bank, the Russian adviser's death threat made me realize that I had to leave the country with my family as soon as possible while my dignity and honour remained intact.

I had to do something for the freedom of my beloved motherland Afghanistan, but from outside rather than inside. Unfortunately, however, the next day, I had to be admitted to a hospital because of a heart attack, where I spent the next four months. Fear of my death and the pain of seeing my country losing its sovereignty had been too much to bear, to stay in my beloved motherland Afghanistan, and do nothing.

Nevertheless, it was evident that choosing between warfare or a peaceful approach was paramount to ending my Afghan nation from imposed inhuman political crises and disasters. Thus selecting either one of them strongly affects the settlement of the issue.

Therefore, people whose nation is facing imposed crises, disasters, and atrocities must be willing to find a solution to achieve the aim of peace and end the crises. The people have to choose between obtaining this goal through a violent struggle or a nonviolent approach.

I am sure that all peace-loving people will agree that the perpetuation of war is not humane for ending such a crisis in a nation. Therefore, we all prefer to solve the imposed war through a dignified and peaceful approach.

I am also a man who has never even handled an air gun. I am someone who hates violence and its perpetrators by nature. I chose the peaceful approach as my direction for everything in life, mainly to serve the needful welfare of my beloved Afghan nation. But after my beloved motherland, Afghanistan was invaded by the Red Army of the Soviet Union, I lost all my hopes.

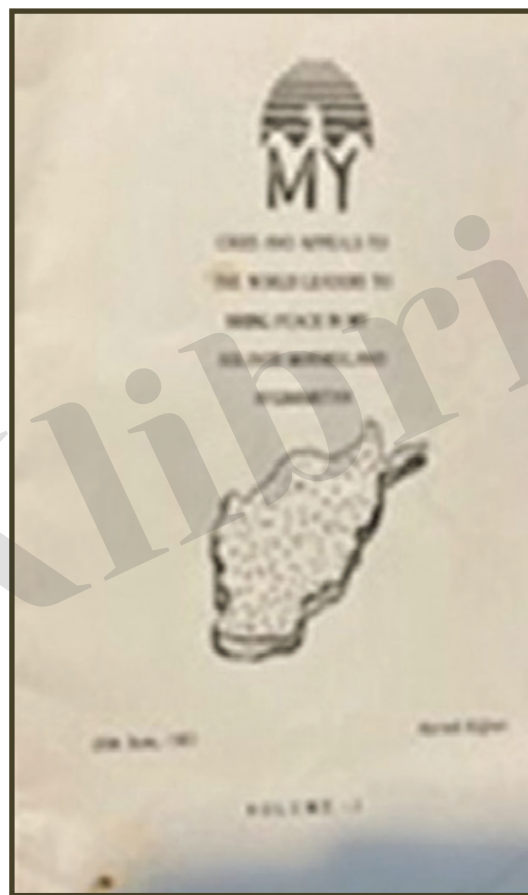
Since then, whether I was in or out of my beloved country, conscientiously been under pressure and mentally disturbed by the unbearable state of affairs in Afghanistan. Hence, to save my Afghan nation from bloodshed, further disaster, and destruction, I have always supported finding a dignified political and peaceful settlement of the Afghanistan issue.

Therefore, my consideration and motive in writing the following letters with some proposals in last 44 years were to open myself without hesitation in approaching the soul and minds of the

world leaders, including the political parties in Afghanistan, Iran, and Pakistan, the secretary-general of the United Nations, the chairperson of the nonaligned conference, the secretary-general of the Islamic conference, and all the peace-loving people of the world, and all my Afghan brothers and sisters.

We ought to, as human beings and defenders of human rights, join our hands together to find a diplomatic solution to the Afghanistan issue and a solution to build an enduring peace and restore freedoms, national sovereignty, and territorial integrity of my motherland Afghanistan. Without peace in Afghanistan, global peace will be but a distant dream.

Thus, to achieve my goal, in March 1981, I managed to get out of Afghanistan with my family and go to Bombay (present-day Mumbai), India, as council general of Afghanistan.



On October 2, 1984, I disseminated my first letter to the secretary-general of the United Nations and the world leaders. Later, on June 20, 1985, I released my first six letters in a booklet titled *My Cries and Appeals to the World Leaders to Bring Peace in My Beloved Motherland, Afghanistan*.

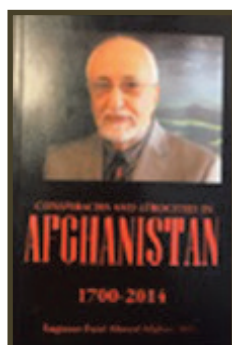
Since then, I have continued to write letters, proposals, hundreds of articles, and several books to express my views and bring to readers' attention the ongoing heart-wrenching atrocities in Afghanistan. So, I am grateful to Mr. Arif Djalili and thank him from the bottom of my heart. The letters and proposals in this book titled “THE CRIES AND APPEALS OF AFGHAN” from August 1984 to 21/02/2021 are my genuine appeals to many world leaders, organizations and individuals, written in my third language over a long period. I have tried to keep them in their original form in this book. However, if there are minor changes in the format or noticing some English mistakes, I humbly apologize.

I hope the reader will better understand the depth of my anguish and my persistently, ever-hopeful longing for the peace and prosperity of my beloved motherland, Afghanistan.

Thank God deposit me all health problems and economical burdens for allowing me to reflect on my cries and appeals from 1885 to 21/02/2021 to reach the heart and minds of readers In these books, Conferences, emails, and hundreds of articles on different websites and Facebook.

Your Excellency,

It is a great honour and pleasure for me to convey my heartiest congratulations and good wishes for Your Excellency's efforts and endeavours to bring about peace in the world.

Your Excellency's efforts towards finding a prestigious solution for the political settlement of the Afghanistan issue are also muchly appreciable to the absolute majority of the people of Afghanistan, the people of the South Asian region, and all peace-loving people of the world.

It is sad that due to the stubbornness of the two superpowers and the selfishness, needless competition and ideological differences of some of the leaders of tiny groups of my Afghan brothers and sisters. They are organized into different parties and forced to disagree with a peaceful approach to the political settlement of the Afghanistan issue. The kind and humane efforts of the United Nations Assembly, conferences of the nonaligned countries, and of the Islamic countries, and even the personal initiatives and efforts of Your Excellency as a General Secretary of the United Nations towards the Political Settlement of the Afghanistan issue have not yielded any positive result. The two superpowers will never agree on the Political Settlement of Afghanistan issue till they have succeeded in imposing their will on the people of Afghanistan and achieving their perfidious aims in Afghanistan and thereby in the South Asian region.

Therefore, I have to say that there is no hope of any political settlement of the Afghanistan issue under the United Nations-sponsored indirect talks in Geneva, beginning on August 24, 1984, unless Your Excellency takes some concrete steps and actions. We Afghans want your influence to be used on the two superpowers to agree on the political settlement of the Afghanistan issue as soon as possible.

Otherwise, not only will the inhuman crisis continue in Afghanistan, but it will also jeopardize the peace in the South Asian region. It is a fact that the majority of the Afghans will never forget their proud history; the two superpowers should realize that the Afghans have an account of taking whatever is theirs by right, through struggle, since they were born amidst their sacrifices in wars and battles.

As such, they are not the people to plead for concessions and forget the proud historical heritage of their forefathers. All the Afghan will struggle and fight for their freedom, independence and national sovereignty till the last breath of the last Afghan. There is a question, why are the people of Afghanistan being misused and sacrificed by the stubbornness of the so-called defenders of human rights, namely, the two superpowers? Suppose the two superpowers are honest and faithful human rights defenders and are willing to bring an acceptable and prestigious peace, freedom, independence and national sovereignty to Afghanistan.

In that case, they should join hands with the United Nations-sponsored mission for the prestigious political settlement of the Afghanistan issue to achieve this sacred and genuine desire.

As an Afghan and a servant of the patriotic people of my dear beloved motherland Afghanistan, I give courage to myself and strongly urge, appeal, cry and humbly request Mr. Ronald Reagan, President of the United States of America, Mr. Konstantin Chernenko, General Secretary of the Communist Party, the President of the Soviet Union, General Zia-ul-Haq, President of Pakistan, Imam Ayatollah Khomeini, the revolutionary leader of the Islamic Republic of Iran, the leader of the People's Republic of China, Mrs. Indira Gandhi, Prime Minister of the Republic of India and Chairperson of the Non-Aligned Movement, the General Secretary of the Islamic Conferences, all other leaders and peoples of the world, my Afghan freedom fighters refugee brothers and sisters, as well as brothers and sisters of the People's Democratic, Afghan Milat, Masawat, Sitam-a-Mili, National Unity, Sholee-Javed, and all Islamic parties of Afghanistan and all my revolutionary patriotic countryman living in Afghanistan and abroad to come together for forgive and forget their differences, disputes, disparity, competition, egotism, hatred, revenge, cruelty, hate, expansionism, hegemonism, exploitation for the sake of Allah, the Holiest of Holies, for the sake of those bridegrooms who lost their brides, brides who lost their bridegrooms, fathers who have lost their kith and kin and innocent young sons and these children have lost their beloved guardians, ladies who have lost their dearest husbands, brothers, sisters, and those brothers and sisters who have lost their legs, arms, nose, ears, eyes, minds, and conscience.

For the sake of those who have lost their dearest relatives, friends, shelters, and orphans who have nobody to look after them.

For the sake of refugees have been living in unbearable conditions abroad.

For the sake of those tortured in prisons and mentally disturbed and embarrassed by looking at their wounds?

For the sake of those wounded whose wounds have not yet healed up, the injured people in the deserts and mountains are losing their lives for a sip of water.

For the sake of those Afghans martyred in deserts and mountains, whose flesh has been eaten by merciless vultures, or those buried alive or who have lost their lives in prison.

For the sake of all, my Afghan brothers and sisters have been suffering from depression and disappointment.

For the sake of those innocent Afghans hanged up in prisons or buried in mass graves.

For the sake of those drowned in the rivers and their flesh being eaten by fish and other animals.

For the sake of those who have been pushed down from the Airplanes, their bodies have been eaten by wild animals and birds.

For the sake of those killed inhumanly by chemicals, even the birds and animals died by eating their flesh.

For the sake of those who have suffocated and lost their lives in the underground gully.

For the sake of those mothers and fathers are still crying and impatiently waiting for their martyred sons and losing their eyesight.

For the sake of those who have been ripped off into pieces due to the blasts of bombs and other evil events that happened in my dear motherland Afghanistan since April 27, 1978.

Finally, for the success of the coming United Nations-sponsored indirect talks in Geneva to stop suffocation, crisis, disasters, afflictions and massacres in Afghanistan, and bring national reconciliation to restore peace, unity, integrity, solidarity, brotherhood, friendship, harmony, independence, national sovereignty, nonalignment and rehabilitation of Afghanistan with a desire established a National Progressive Democratic Republic Government in Afghanistan, and a genuine desire to build a new blossomed and splendid Afghanistan for the noble, kind, patriotic, robust, brave, proud, manly, generous, well-built, stalwart, virile, steadfast, potent, gallant, warlike, brave, warriors, hospitable and peace-loving people of Afghanistan.

It is also a great privilege and honour for me to draw your kind attention to my proposals enclosed for the political settlement of the Afghanistan issue. I hope some of the points will be useful in future talks and a copy of this letter. Finally, I approach with a request to the involved and concerned leaders and parties for their urgent, kind, genuine, loyal, sympathetic, positive, and humane action towards the prestigious political settlement of the Afghanistan issue. I avail of this opportunity to renew my appeal to Your Excellency and assure you of my highest confederation.

A PROPOSAL FOR THE PRESTIGIOUS POLITICAL SETTLEMENT OF THE AFGHANISTAN ISSUE

A. MAIN PRINCIPLES:

A.1. Political recognition of the Democratic Republic of Afghanistan as a transitory government for a period of continuous fifteen-month by those governments who have recognized the Republic of Afghanistan before April 27, 1978, to start direct talks between the transitory Government of Afghanistan and Governments of the Republic of Pakistan, Islamic Republic of Iran, and the Representative of a United body of all the Afghan refugees, under the auspices of the United Nations to reach a positive and a generally acceptable prestigious political settlement of the Afghanistan issue, based on the following items.

A.2. Non-interference of the other states in the internal and external affairs of Afghanistan, mainly by the Governments of the Republic of Pakistan, Islamic Republic of Iran, Republic of India, People's Republic of China, the Soviet Union, and the United States of America.

A.3. The prestigious and honourable gradual return of all the Afghan refugees from the soil of Pakistan and Iran to Afghanistan with the simultaneous smooth and gradual recovery of all the Soviet troops from Afghanistan to the Soviet Union in the twelve-month continuously as mentioned in the implementation program of the plan of operation for the political settlement of the Afghanistan issue.

A.4. Establishing a new Parliamentary System under the name of NATIONAL PROGRESSIVE DEMOCRATIC REPUBLIC OF AFGHANISTAN (MADRAS), which will comprise educated, intellectual, progressive and authorized members who are elected freely & fairly of the people's Democratic, United Islamic, Shola- e-Javed, Afghan Milat, Massawat, Sitam-e-Milli, National Unity and other recognized parties in Afghanistan.

A.5. Recognizing Islam as a sacred state religion, respecting the national traditions, cultures, languages, and different sects and other religious groups in Afghanistan.

A.6. Maintaining national independence with national sovereignty, territorial sovereignty, national integration, national benefits, non-interference of religion, language and other sects in the political affairs, and also active and positive nonalignment, freedom of judgment in internal and international affairs, respect for the united nations charter, mutual friendship, and respect for the neighbouring as well as Islamic countries, and all other peace-loving nations of the world.

- To reorganize the national life in Afghanistan according to the requirements of the time and based on the realities of national history and culture.
- To achieve justice, equality and legality in all sections of Afghanistan.
- Organize the functions of the state and its branches to ensure all democratic, political, and social liberties and the welfare of all the individuals in the sections of Afghanistan.
- To achieve all individual and social security in all sections of Afghanistan.
- To achieve a balanced development of all phases of life in Afghanistan.
- Organize the functions of the state and its branches to ensure the speedy rehabilitation of Afghanistan.
- To form, ultimately, a prosperous and progressive society based on social cooperation and preservation of dignity & honour.

A.7. Agreement of all the concerned parties, particularly the transitory Government of Afghanistan and the Governments of Pakistan, Iran, Soviet Union, China and the United States of America, on enforcement of the implementation programme of the plan of operation for the political settlement of Afghanistan issue by an International Monitoring Team.

A.8. Approval of the Security Council, particularly of all its permanent members of the Security Council of the United Nations on the Main Principles for the political settlement and the implementation programme of the plan of operation for the political settlement of the Afghanistan issue.

B. IMPLEMENTATION PROGRAMME OF THE PLAN OF OPERATION

B.1. - FIRST PHASE (THREE CONTINUOUS MONTHS)

B.1.1 - Establishment of international centers under the direct control of the sponsored missions of the United Nations to create a Special Relief Fund for the return and settlement of the Afghan refugees into their respective native places for the overall rehabilitation of Afghanistan.

B.1.2 - Finding the total number of Afghan refugees by distinguishing men, women and children in Pakistan and Iran by the United Nations mission through collaborative efforts of the hosting countries of the refugees and the authorized representatives of the refugees in these countries.

B.1.3 - Geographically distributing Afghanistan into six regions on the Afghanistan map and finding the number of Afghan refugees in each region stationed in Pakistan and Iran by the mission appointed by the United Nations.

B.1.4 - Presenting the actual number of the Soviet troops, including captains, commanders, and all military advisers, stationed in Afghanistan by the said mission of the United Nations.

B.1.5 - Finding the ratio of the Soviet troops in Afghanistan and the Afghan refugees on the soils of Pakistan and Iran based on the information of items no. B 12, B 13, B 14, by the Joint Mission

of the transitory Government of Afghanistan and the Government of Republic of Pakistan and the Islamic Republic of Iran under the defect collaboration of the United Nations missions for the political settlement of Afghanistan issue.

B.1.6 - Appointing a joint mission, including the representative of the transitory Government of Afghanistan, to fix the type and amount of the relief fund and the distribution of international relief funds for the Afghan refugees after their return to their respective native places in Afghanistan.

B.1.7 - Providing and furnishing information regarding the actual number of Afghan refugees by the other hosting countries in their receptive countries and arrangements for their prestigious return to Afghanistan, presenting the same to the mission appointed by the United Nations.

B.1.8 - Fixing the schedule and programme for the return and disarmament of the refugees of each region in six different stages according to the number of refugees in each area and simultaneous return of The Soviet troops to the Soviet Union in proportion to the number of Afghan refugees returned to each region

B.2. - SECOND PHASE (TWELVE CONTINUOUS MONTHS)

B.2.1 - Declaration of the schedule and programme of the gradual return and disarmament of the Afghan refugees from Pakistan and Iran to Afghanistan according to the fixed regions in six different stages during the twelve continuous months, followed by the declaration of the schedule and programme of the simultaneous gradual return of the Soviet troops to the Soviet Union from Afghanistan.

B.2.2 - Commencement of the gradual return of all the Afghan refugees and the simultaneous gradual recovery of the Soviet troops to the Soviet Union according to the programme, as mentioned in item Nos. B.1.5, B.1.6, of phase one, and item no. B.1.2 in phase two.

B.2.3 - Blocking the returned refugees of each region by the United Nations Peacekeeping force till the end of the gradual return of all the Afghan refugees to their native places in Afghanistan and the simultaneously gradual return of all Soviet troops to the Soviet Union.

B.2.4 - Blocking the routes of the refugees to Pakistan and Iran by the United Nations Peacekeeping force till the final return of all the refugees.

B.2.5 - Declaration of a program for returning Afghan refugees from other countries to Afghanistan according to the program fixed in item no. B.1.7 in phase one.

B.2.6 - Releasing all the prisoners who have been imprisoned since April 27, 1978.

B.2.7 - Declaring the "WINDING UP" of the program and successful implementation of the schedule and plan for the gradual return of all the Afghan refugees to Afghanistan and a

simultaneously gradual return of all the Soviet troops, commanders, captains and military advisers to their country.

B.3. - THIRD PHASE (FIVE CONTINUOUS MONTHS)

B.3.1 - Dissolution of the transitory Government of Afghanistan and declaration of national reconciliation, harmony, solidarity and integrity in Afghanistan.

B.3.2 - Establishing an INTERIM NATIONAL MULTI-PARTY COUNCIL (INMPC) made of leaders and the authorized representative of each party mentioned in items nos. A.4, A.5, A.6, A.7, A.8, with a chairperson belonging to a neutral body which would be acceptable to all members of (INMPC).

B.3.3 - Assigning an absolute neutral, immaculate, loyal, patriotic Prime Minister by (INMPC) who will be capable and acceptable to all the members of the cabinet for forming the Interim Government in which all the cabinet members will consist of the nominees of the parties mentioned in item nos. A4, A5, A6, A7, A8.

B.3.4 - Appointing a Committee by NMPC under the direct Chairmanship of the Prime Minister to prepare the new constitution according to the instructions given in item No. A 4.

B.3.5 - Holding a free and fair national election for the Grand National Assembly throughout the country under the direct supervision and control of the Interim Government and the International Monitoring Team for the Grand National Assembly, which would be convened in the city of Kabul for sanctioning the new constitution.

B.3.6 - Declaring the sanctioning of the new constitution of the NATIONAL PROGRESSIVE DEMOCRATIC REPUBLIC OF AFGHANISTAN and holding free and fair national elections for the Parliament, and inauguration of the Parliament by the President of the Interim National Multi-party Council to elect a new President and members of the First National Multi-Party Council from amongst the elected member of the Parliament. A new Prime Minister of the National Progressive Democratic Republic of Afghanistan should also be appointed by NMPC, and they must introduce the Prime Minister for acceptance to the National Multi-Party Parliament and, after that, announce the political settlement of the Afghanistan issue and thereby commencing new life in Afghanistan.

Your Excellency,

I have the honoured state that appears to be the follow-up of my letters of August 2, 1984, which I feel Your Excellency must have received before the 3rd round of indirect talks on the Political Settlement of Afghanistan issue in Geneva. A copy of my previous letters addressed to Your Excellency is herewith attached.

As mentioned in my previous letter, the talks did not yield a positive solution. Therefore, according to my speculation, the superpowers, for reaching their perfidious aims once again, got some time for the massacre and making the innocent and poor people of Afghanistan fight and ultimately kill each other.

I am sure that the fourth round of indirect talks, after a lapse of six months, will be the same as the last three rounds. One of the reasons is the non-unity among the refugee brothers and sisters for introducing their one representative to the United Nations to participate in the United Nations indirect talks sponsored by the United Nations.

The other reason is that the Soviet Union was not prepared to give the schedule for the withdrawal of their troops, and they weren't interested in committing the departure of their forces from Afghanistan.

Therefore once again, I request all brothers and sisters humbly belonging to all known political parties, heroic military brothers and sisters, all the civilian brothers and sisters, and all my patriotic fellow citizens living in Afghanistan and abroad to give up their differences & individual struggle and killing each other for power and foreign ideologies such as socialism, imperialism and so on. I would therefore appeal to my brothers and sisters to tread the path of our Afghan ancestors and be united to form a strong, solid, iron force against the natural foreign enemies to get freedom, independence, national sovereignty and peaceful life.

We must strive hard to establish the federal regressive democratic Republic Government in Afghanistan. I also request the refugee brothers and sisters to introduce themselves as one united body to the United Nations and introduce one representative to the United Nations to

join the Mission of Political Settlement of the Afghanistan issue under the sponsorship of the United Nations.

May I humbly request Your Excellency to explain and give an accurate picture of the happenings of events in Afghanistan and provide a summary of the three rounds of the indirect talks to the members of the coming General Assembly? This would allow them to make some reasonable and practical decisions regarding the prestigious political settlement of the Afghanistan issue.

Could I also request Your Excellency to emphasize some positive and urgent steps, please, while using your good influence on the leaders of the Soviet Union, the United States of America and other powers involved in the Afghanistan issue, to achieve a mutual agreement for the prestigious political settlement of the Afghanistan issue?

I would also request Your Excellency to please not mix and link the Afghanistan issue with the general political situation of the world. If the matter is connected with the prevailing situation, the Afghanistan problem will never be solved.

Kindly do the needful to find the right solution to expedite the issue to bring peace, freedom, independence, national sovereignty, territorial sovereignty and non-aligned status to Afghanistan as soon as possible. Otherwise, the foreign enemies of Afghanistan will bring the war beyond the borders of Afghanistan and thereby create a new problem by which Afghanistan will lose its identity and its freedom, independence and national sovereignty and territorial sovereignty forever.

Your Excellency,

It is my pleasure and honour to congratulate you on your election as General Secretary of the Islamic Conference. I wish you all the best and grand success in all walks of your dynamic personality.

I know you will face many crucial problems in your new assignment, facing present critical conditions of the world and finding an immediate solution for each of these problems. But, I'm here to speak to you as an Afghan who has been seeing and seriously observing the severe crises in my dear beloved motherland of Afghanistan since April 1978, particularly after the open military invasion of the Soviet Union on December 27, 1979.

It has resulted in the brutal killing of innocent people, destroying their property, torturing them, putting them in prison without any reason and forcing them to leave their beloved country and live in unbearable rather miserable conditions. Therefore, I consider this one of the most crucial and immediate problems to be given priority in Your Excellency's tasks.

Since you are not biased by the policies of either of the two powers, instead you are willing very sincerely to act like a man of peace, enthusiastically interested in preserving and maintaining stability in the region, and thereby in the world; I would humbly request Your Excellency to kindly take immediate, strong and positive action on humanitarian ground and to find the solution for the Afghanistan issue as soon as possible.

This is because the Soviet Union and the United States of America have their eyes on achieving their hegemony and colonial aims in the region and the world and trying their utmost to create hurdles for aborting the indirect talks in connection with the political settlement of the Afghanistan issue to be held in Geneva under the auspices of the United Nations, under such circumstances for the last few months the Government of the Democratic Republic of Afghanistan is compelled to accuse the Governments of Pakistan and Iran for their aggression.

Likewise, Pakistan and Iran are also accusing Afghanistan in the same manner; thereby, they are indirectly expressing their unwillingness to continue the indirect talk and trying to make the 4th round of indirect negotiations for a political settlement of the Afghanistan issue more

challenging and unlikely to be held next February, as was scheduled during the 3rd round of indirect talks in Geneva.

There is doubt that the Soviet Union is trying to considerably increase its military ties and force in Afghanistan in the immediate future to seal off the so-called borders of Afghanistan and Pakistan, the boundaries of Afghanistan with Iran, and ultimately isolate Afghanistan from the rest of the world.

This will result in Afghanistan just maintaining its flag and representation in the United Nations, like the Republic of Ukraine of the Soviet Union and being called an independent country.

But, still, in reality, it would be the 16th Republic of the Soviet Union with no freedom, independence, national sovereignty, territorial sovereignty and nonalignment status forever.

After having it under its complete and direct domination, it is then swallowing all the new natural resources of Afghanistan and using the soil of Afghanistan as a platform for the next jump to Pakistan, India, the Indian Ocean and the Persian Gulf.

But, on the other hand, the United States of America, on the pretext of maintaining peace in the region and defending the rights of Afghans, fighting the Soviet Union to the last Afghan, is trying to change the soil of Pakistan as their Military base against Soviet Union Afghanistan, Pakistan, India, Iran Indian Ocean & Persian Gulf, as a result of the actions of the superpowers, the poor, innocent, peace-loving people of Afghanistan, Pakistan, India and Iran would suffer. It would have to pay the price now and in future.

Therefore, once again, I humbly suggest the following proposal to Your Excellency for the cause of the prestigious political settlement of the Afghanistan issue to maintain peace in the South Asian region and the world.

1. Please call upon a joint mission talks with His Excellency Mr. Javier Perez Culler, General Secretary of the United Nations, His Excellency Mr. Raheev Gandhi, the Prime Minister of India and the Chairperson of the Non-Aligned Movement, to discuss the crises of Afghanistan and take some concrete positive decisions to achieve the solution for the prestigious political settlement of Afghanistan issue.
2. The decision arrived at the joint mission to be forwarded to the so-called human rights, Mr. Ronald Reagan, President of The United States of America and Mr. Konstantin Chernenko, Leader of the Soviet Union.
3. Once this agreement has been achieved, a summit Conference of the authorized representative of the government of the Soviet Union, United States of America, China, Afghanistan, Pakistan, and Iran and an acceptable elected representative of all Afghani refugees who are settled either in Pakistan, Iran and other parts of the world, be called in Geneva under auspices of H. E. Mr. Javier Perez de Cuellar, General Secretary of the United Nations, H.E. Mr. Rajiv Gandhi, Chairperson of the Non-Aligned Movement and Your Excellency General Secretary of Islamic

Conference. You are requested to go through the proposal and agree upon the decision to forward it by ratifying it for approval by the United Nations.

4. One of the obstacles regarding the indirect talks on the prestigious political settlement of Afghanistan issue under the auspices of the United Nations has unfortunately not yielded a final positive solution. Due to the non-unity amongst the Afghan refugees in Pakistan, Iran and other parts of the world. The apparent reason for their not being united is that the enemies are still using the policy of divide and rule among the Afghan refugees.

The latter has been segregated into many groups under different names with different Leaders, and each group is connected to another financial supporter who has been obliged to follow their instructions. Failing to do so would result in them losing their privileges.

I would therefore like to express by saying that if the same prevailing conditions dominate the Afghan refugees, there will be no unity amongst the refugees against their common enemies for the cause of restoring peace, freedom, independence, national sovereignty, territorial sovereignty and non-aligned status of their beloved motherland Afghanistan and hence all financial assistance from different sources would not only be helpful to solve the problem of Afghanistan but, the bloodshed and crises will drag on till the last Afghan.

Then, finally, the Soviet Union would win the battle and reach the Indian Ocean and the Persian Gulf.

In connection with the unity of all the different leaders of the Afghan refugees, I would like to request Your Excellency to take the initiative to solve this significant problem as soon as possible. I am also forwarding the following points to Your Excellency as my personal views for the cause of the unity of all my brave revolutionary refugee brothers and sisters.

a. The humanitarian help and assistance of the Government of Pakistan, Iran, Islamic countries and all other peace-loving nations should be brought under one umbrella.

b. All financial organizations should join and form a Coordination Committee in one center for collecting donations and assistance on a humanitarian basis.

c. All humanitarian financial assistance thus collected should be distributed directly under the supervision of the representatives of the Coordination Committee to all the brave.

d. The leaders of different groups of all the Afghan revolutionary refugees stationed either in Pakistan, Iran, or other parts of the world and the representatives of the governments of Pakistan and Iran be called to the Coordination Center to discuss the essentials of unity of different leaders of Afghan refugees for the cause of encouraging the financial sources for getting the humanitarian assistance required for meeting their needs and the distribution to all Afghan refugees by proper and fastest means the ways.

e. After achieving unity amongst different leaders of the refugees only, one person as a leader for all the refugees be elected and introduced to the Coordination Committee as a contact person with the responsibility of all financial matters as a single leader in the summit conference mentioned in item no.2 and the same person could be at the indirect talks on a prestigious political settlement of Afghanistan issue, by the United Nations.

After achieving a concrete and positive proposal for the prestigious political settlement of the Afghanistan issue, it would result in the simultaneous smooth withdrawal of all Soviet Union Military forces from the soil of Afghanistan and dignified return of all Afghan refugees from the ground of Pakistan, Iran and the other parts of the world. It would thereby restore peace, freedom, national sovereignty, territorial sovereignty and the non-aligned state of Afghanistan.

Your Excellency as General Secretary of the Islamic Conference, His Excellency Mr. Javier Perez de Cuellar, General Secretary to the United Nations and His Excellency Mr. Rajeev Gandhi, Chairperson of the Non-Aligned Movement, unitedly will make an invaluable contribution to the cause of preservation of peace in the region and ultimately in the world.

By the way, I would also like to refer to the enclosed copies of my letters and proposals for the political settlement of the Afghanistan issue dated August 2, 1984, along with letters dated September 10, 1984, addressed to His Excellency Mr. Javier Perez de Cuellar, General Secretary of the United Nations and the letter dated December 31, 1984, addressed to His Excellency Mr. Rejeev Gandhi, Prime Minister of India and the Chairperson of the Non-Aligned Movement, for your perusal.

However, it is worth mentioning that at present, for the people of Afghanistan, Pakistan, Iran, India and all other peace-loving people of the world, the unjustifiable aggression and presence of the Soviet Union military Forces and the unbearable situation in Afghanistan are the most vital issue and should be given the top most priority in your immediate and plans and programmes.

Your Excellency, please allow me to quote part of your speech as a tribute to the late Mr. K. U. Chernenko for his efforts to half the arms race, "WE AGAIN REAFFIRM THE PRINCIPLES OF GOOD NEIGHBORING RELATIONS IN PEACEFUL COOPERATION, BUT WE SAY AT THE SAME TIME THAT NO ONE WILL BE ABLE TO IMPOSE HIS WILL ON US."

In this connection, I would like to express that it could have been more appropriate by adding and saying in your speech, "WE WILL ALSO NEVER IMPOSE OUR ON OTHERS," as for the principles of good neighbourly relations and peaceful co-operation in Your Excellency's speech.

I would also like to say that the people of Afghanistan, from the early days of our great and beloved king Amanullah Khan and your great Leader Mr. Lenin, have established good, cordial and friendly relations between the two countries by exchanging letters dated April 7, 1919, & May 27, 1919, respectively which subsequently resulted in a treaty of the friendship of February 28, 1921, later on, a treaty of mutual non-aggression of August 31, 1926, between the two governments of Afghanistan and the Soviet Union (a copy of which is enclosed for your kind perusal) ever since every five or ten years the treaty of non-aggression between the two governments have had been reaffirmed of which the last one was in the year 1975.

The people of Afghanistan were faithful and loyal to the people of their great neighbour, the Soviet Union and, day by day; the economic, political and technical relations were strengthening and getting closer and closer.

But, despite the faithfulness and loyalty of the people of Afghanistan to the people of the Soviet Union, all of a sudden, without any reason, on April 27, 1978, and later on December 27, 1979, abolished all the promises and treaties between the government of the two neighbouring countries (Afghanistan & Soviet Union).

This was done by the late Mr. Brezhnev, the then leader of the Soviet Union, and the same policy had been pursued by your other two predecessors, Mr. Yuri Andropov and Mr. K. U. Chernenko, resulting in the brutal killing of the innocent people of Afghanistan, destroying their houses and properties, and forcing them to leave their beloved motherland Afghanistan and live as refugees in every unbearable condition in neighbouring countries (Iran & Pakistan) and other countries of the world, leaving thousands of people handicapped and homeless.

Due to this, not only the people of Afghanistan were discontent. They lost their faithfulness and loyalty to the people of the Soviet Union. Still, internationally, the issue of the invasion of the Soviet military forces in Afghanistan has been strongly criticized by the world. It has been condemned several times by the majority of the General Assembly of the United Nations, Summit conference of the Non-Aligned Movement, Islamic meeting & other peace-loving organizations for the last six years.

Despite the initiatives which have been taken by His Excellency Mr. Javier Perez de Cuellar, General Secretary of the United Nations, to find a solution for the political settlement of the Afghanistan issue and three rounds of indirect talks under the sponsorship of the United Nations have already been conducted between the government of the Democratic Republic of Afghanistan and the government of the Republic of Pakistan in Geneva.

But, still, unfortunately, none of them has yielded any solution because of the obstinate nature of the two superpower leaders (Soviet Union & United States of America), which badly affected the prestige of both superpowers.

Now Your election as a new leader of the Soviet Union and Warsaw Pact and as you have been praised for your benevolent nature by the leaders of the world who joined the funeral of late Mr. K. U. Chernenko brings hope to the people of Afghanistan and all the peace-loving people of the world, waiting in high expectations, looking forward to Your Excellency to take humanitarian, rightful, positive and robust initiatives jointly with your colleague, Mr. Ronald Reagan, President of the United States of America with the cooperation of His Excellency Mr. Javier Perez de Cuellar, General Secretary of the United Nations, His Excellency Mr. Peerzadah, General Secretary of Islamic Conference to end the crisis in Afghanistan with the prestigious withdrawal of all your troops from Afghanistan. I urge the refugees to be allowed to return to their beloved motherland Afghanistan from the neighbouring countries (Pakistan & Iran) and other parts of the world and restore freedom, independence, national sovereignty, territorial sovereignty and finally, the non-aligned status of Afghanistan and also for yielding my genuine desire for bringing peace in Afghanistan.

I avail this opportunity to appeal to the other six members of the Warsaw Pact to discuss the said matter very thoroughly without any fear at the Summit Conference of the Warsaw Pact scheduled to be held in Warsaw, Capital of Poland, in coming April to achieve a meaningful, positive, humanitarian division for ending the present crisis and bringing peace in Afghanistan reestablishing a new cordial and friendly relation between the people of Afghanistan with the people of Soviet Union, all socialist countries and all other Peace-loving people and countries of the World.

With a copy of this letter, I would also like to draw the kind attention of His Excellency Mr. Javier Perez de Cuellar, General, Secretary of the United Nations, His Excellency Mr. Rajive Gandhi, Chairperson of The Non-Aligned Movement, and the leaders of the six other countries of the Warsaw Pact Mr. Peerzadah, General Secretary of the Islamic Conference to join you in achieving a rightful, favourable, mutual agreement for the restoration of the prestigious peace in Afghanistan, which ultimately will bring peace in the South Asian region, and ease the tension existing in the world.

By achieving this sacred desire, not only will you take an essential humanitarian step toward peace, but it will be an act of great price for all of you.

I wish you good luck in your most courageous task; I avail this opportunity to renew to Your Excellency the assurances of my highest consideration.

Let me respectfully express that the Air Craft is the fastest and safest means of transportation in the world. Still, unfortunately in the last decade, by the inhuman terrorist actions of plane hijackers, the life of humanity has poorly been threatened with death.

On the contrary, we have been witnessing the loss of lives of more than a thousand innocent people in different bloody tragedies by hijacking planes in a distant corner of the world.

As a human being, I share my deepest and profound grief with all the bereaved families who have lost the precious lives of their dearest family members and those who were injured in the ill-fated Pan Am Flight 073 on September 5, 1986, in Karachi, I would therefore like to request Your Excellency to call in all the member countries in the Coming General Assembly of the United Nations, to start a worldwide struggle for eradicating all sorts of terrorist actions on the surface of the world, including the eradication of hijacking the planes.

To achieve this sacred goal successfully, I may also request Your Excellency to declare the year 1987 by adopting a resolution in the coming General Assembly of the United Nations as “World Wide Terrorism Eradication.”

With the fulfillment of this objective, it would be for all the States and World Organization to take decisive and effective measures to reach this sacred and humane goal of eradicating the disastrous and bloody terrorism throughout the world successfully.

Indeed it is also a great pleasure to submit my personal information to the International Air Transportation Association (IATA) to tackle the deadly problem of hijacking planes worldwide.

A PROPOSAL FOR DEFUSING HIJACKING PLANS OF AIR CRAFTS

To end the perfidious and disastrous plans of the Air Crafts Hijackers without any Craft hijackers without any casualties and tensions to the crews and passengers on board, it is necessary to install an "Instant sleeping system" inside the plane, in a way that when the plane lands and comes to complete half, immediately the oxygen inside the aircraft should be cut off and instead, the instant sleeping gas should be released by a remote controller installed in the control tower.

To avoid damage to the plane after the completion of the first operation, it is necessary to build extra automatic escaping doors on different parts of the Air Crafts. These doors should also be only operated by remote control from the Control Tower.

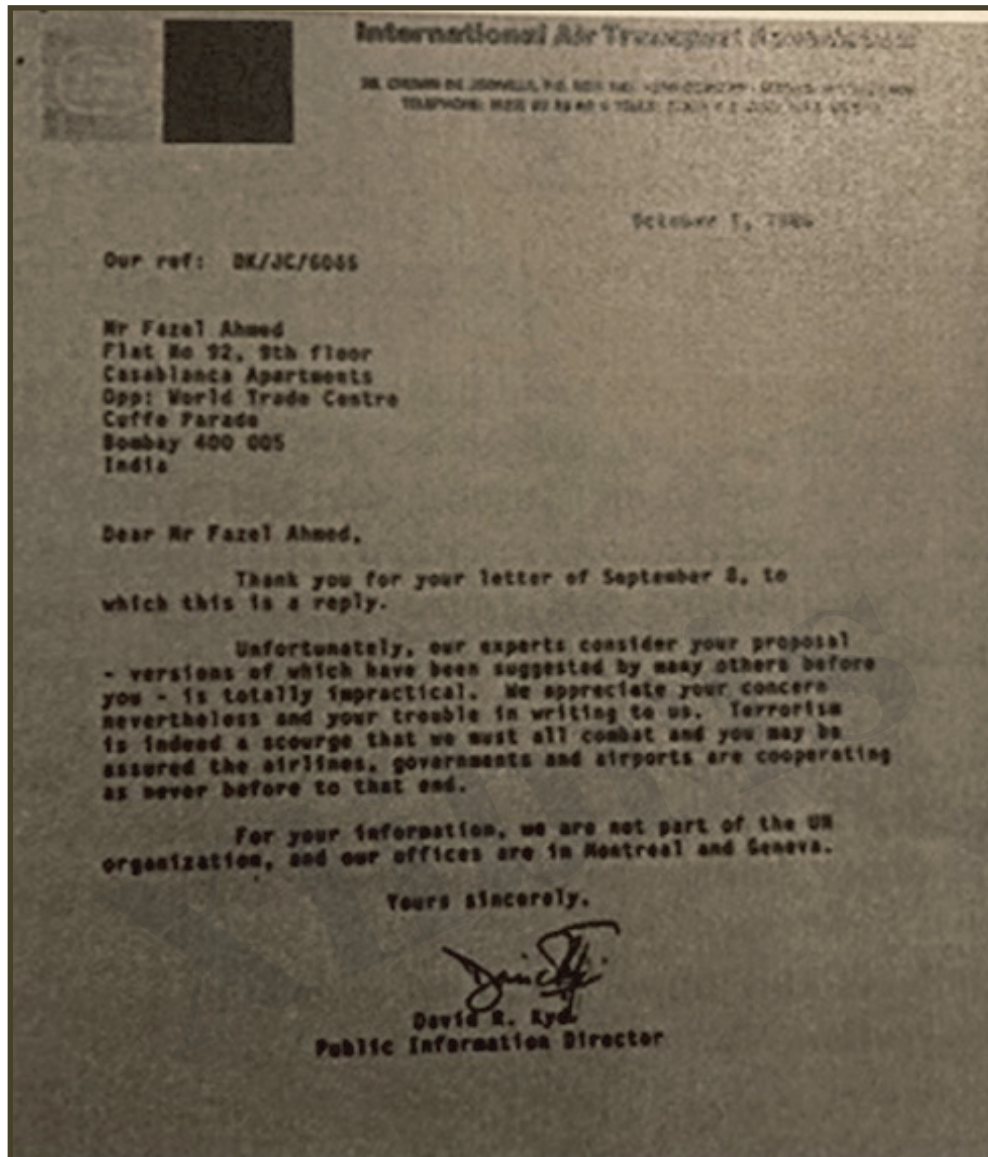

Though in the last forty-one years of the United Nations, the speedy growth of population with different political and economic ideologies, accession of newly independent countries, the tremendous development of advanced Nuclear and other deadly sophisticated arms, the boom of high technology and the creation of new international organization such as NATO, OPIC, NAM, SAARO, Warsaw Pact and Islamic conference with different political and economic policies, have entirely changed the picture of the world and forced the United Nations to face difficulties and failures.

But it is a fact that despite the above-mentioned dramatic changes and madly struggle of the two superpowers for seeking world domination through an arms race on the earth and in outer space and their interferences in the United Nations, Your Excellency's endeavours, efforts, and stand in last five years as General Secretary of the United Nations to bring about peace and international economic order in all peace-loving people of the world.

The failure of the two superpowers to reach an accord in their summit meeting in Reykjavik on October 11–12, 1986, has once again proved that the leaders of the two superpowers are not genuinely willing to bring about peace and prosperity for the people of the world.

After achieving this, it would be possible to introduce some modifications to the United Nations Charter according to the desire and needs of the present and future world, thereby making the world a place for humanity to live in with peace, honour, dignity, and justice, equality, and prosperity.

In connection with my dear beloved motherland Afghanistan, I would like to express and reiterate that the withdrawal of only 8000 out of 1,20,000 Soviet troops from Afghanistan this month is insignificant; there is no sign of any change in the stand and position of the Soviet Union regarding the withdrawal of all their troops to give an end to the ongoing bloodshed in Afghanistan.

Therefore, I urge Your Excellency to take some strong and positive steps and immediate actions to convince the leader of the two superpowers to reach a rapid agreement regarding the positive, prestigious and acceptable political solution for the settlement of the Afghanistan issue.

I avail of this opportunity to assure Your Excellency of my highest consideration.

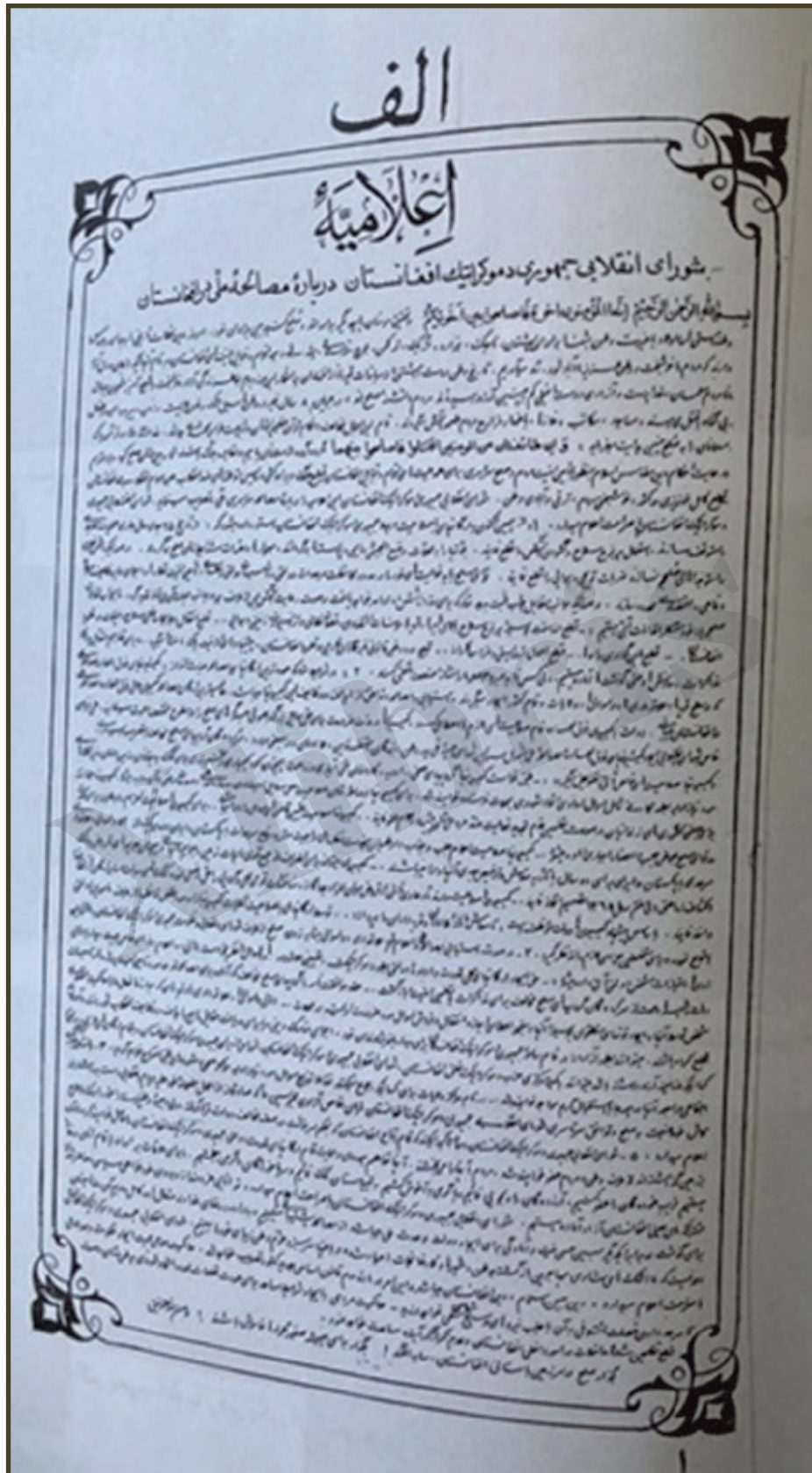

It is indeed a great pleasure to say that at this happy stage, I have the news of substantial progress in the 8th round of proximity talks between Afghanistan and Pakistan on the Afghanistan issue from February 25 to March 10, 1987. It is an inspiring hope towards achieving a generally acceptable peace accord in the 9th round of proximity talks scheduled to be held in May or June 1987 in Geneva.

Diego Cordovez, the United Nations, Non-Aligned Movement Conference, Islamic Conference, Peace-loving people and Organization of the World for their untiring and indefatigable humanitarian endeavour towards the hopeful fulfillment of a peace accord to restore the independence, freedom, national sovereignty, territorial sovereignty, national integration and the nonaligned status of my beloved country, and those of my Afghan brothers and sisters. They have continuously struggled and sacrificed their lives to prove that the Afghans have a proud history of taking what is theirs right through struggles in the last seven years.

There is no doubt that the coming Geneva accord will be another landmark in the annals of the United Nations and will be regarded and recorded in the history of Afghanistan and the world.

Therefore to achieve this sacred desire, I humbly appeal once again to Your Excellency, leaders of the two superpowers, world organizations, and all concerned parties, that the coming talks in Geneva should not be allowed to face frustration and failure. Instead, it must end to a generally acceptable peace accord for the settlement of the Afghanistan issue, as well as creating the special relief fund centers for the return and payment of Afghan refugees to their native places and extending unconditional economic as well as technical aid for rehabilitation, reconstruction, and above all, development of my dear beloved motherland Afghanistan.

It is a fact that the peace accord will be the beginning of a process leading to the end of the ongoing imposed crisis bloodshed in Afghanistan. However, achieving complete and successful peace in Afghanistan will depend only on the honesty, sincerity and vigilance of all the parties involved in implementing the peace accord.

Thus in this connection, I very humbly appeal to all the parties involved to maintain their vigilance and be sincere and honest in successfully implementing the coming peace accord. I also appeal to everyone to strongly express that the keys to immediate and perpetual peace and prosperity in Afghanistan lie in a firm and unshakable unity, solidarity and integrity among all my loving Afghan brothers and sisters against their common enemies. Otherwise, Afghanistan in the South Asian region will also have the same fate as Lebanon in the Middle East, facing endless bloodshed, brother killing, crisis and destruction.

I avail of this opportunity to assure Your Excellency of my highest consideration. A new early acknowledgment of this letter will be highly appreciated.

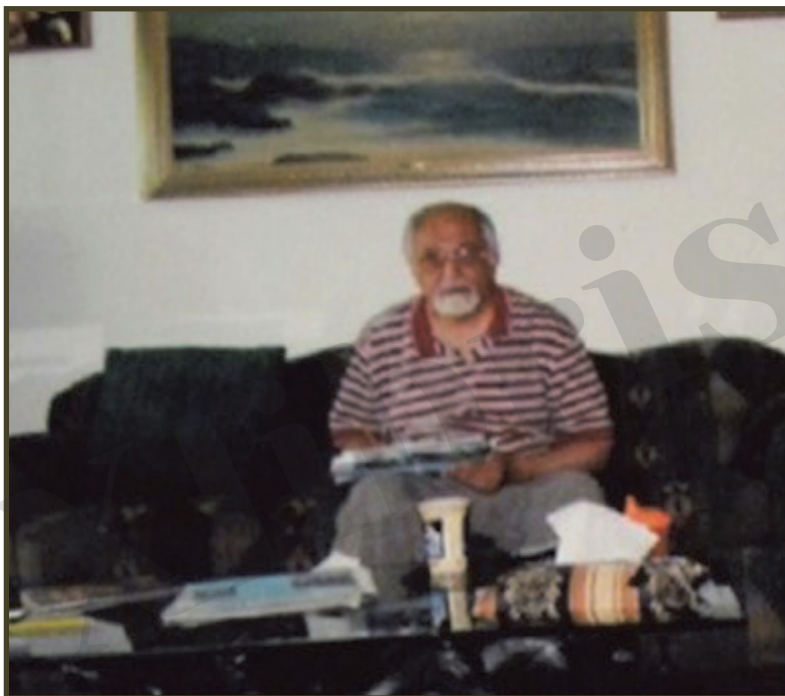

May I have the pleasure and honour to express that during the three-day Summit Talks between Mikhail Gorbachev and Ronald Reagan on December 10, 11, and 12, 1987, in Washington DC.

The signing of a treaty to eliminate the superpowers' medium-range nuclear missiles was a landmark in the history of the world. Still, it was also very disappointing and sad to learn that due to the differences of opinion of the leaders of the two superpowers, the talks made little progress toward yielding an acceptable and prestigious solution for the political settlement of the Afghanistan issue.

Indeed it would have been desirable to end the ongoing bloodshed and destruction in my dear country, Afghanistan. Therefore, on the sad occasion of the ninth anniversary of the invasion of Afghanistan (December 27, 1979), my dear fellow citizens mourn and, along with other peace-loving people of the world, condemn the open and brutal invasion of the Soviet Union into Afghanistan. Therefore, I once again, as a servant of my dear Afghan brothers and sisters, very humbly request Your Excellency to express your most profound concern and unhappiness on the failure of the talks between the two leaders on the Afghanistan issue.

Further, I would request that you urge the leaders of the USSR and the USA to reach a favourable mutual agreement to restore peace, independence, freedom, national sovereignty, territorial sovereignty, national integration and nonaligned status of Afghanistan as soon as possible.

I also humbly appeal to the Congress of the United States of America to ask the Soviet Union to submit a generally acceptable timetable for withdrawing their troops from Afghanistan before the treaty of medium-range nuclear missiles is ratified by the American Congress.

Although I had concluded my cries and appeals to the world leaders in my previous Letter No. XVI addressed to Your Excellency on March 21, 1987; on this occasion, it is my duty to appeal to the world leaders to join the cries of all peace-loving Afghans and strongly condemn the Soviet Union's invasion of the beloved motherland of all heroic and patriotic Afghans.

A Proposal for Fundamental Changes in the Government of Afghanistan by Engineer Fazel Ahmed Afghan

As is known to everybody, the slogan of President Obama during the campaign was “Change.” Of course, the purpose of the motto of change was not merely the changing of a white President to a black President. Still, his sincere desire was to introduce fundamental changes in the scattered socioeconomic, political and military status of America at the national and international levels so that he could introduce rapid change.

As a result, all-sided developments not only regain the prestige of the United States of America throughout the world but also elevate it. In other words, the slogan of change which reflects Mr. Barack Obama’s sacred national goals has made him a beloved leader to both white and black Americans and enabled him to become the leader of the most powerful nation on Earth and to govern this nation.

Indeed, the American nation, by electing Mr. Obama, proved to the world that their national interests are higher than colour, minority and majority. That purity, sincerity, honesty, knowledge, patriotism and broadmindedness are qualities which constitute the character of Mr. Obama and which gained him success in the election at both national and international levels. In addition, he stood free of the old and unpopular contradictions and forgotten inhuman values.

Unfortunately, the oppressed nation of Afghan would soon face once again, consciously or unconsciously, a vital national trial, that is to say, that contrary to what we observed in the American election, many unworthy personas are planning to hold an election, using the slogans of ethnic, religion and region or cheating people by misinterpreting the articles of the constitution.

They aim to collect votes from illiterate, uninformed and ignorant people to establish themselves as winners. This is happening at a time when the national infrastructure is destroyed; the nation is fighting an imposed war, the census has not been taken, local consultative assemblies have not been established, security does not exist, millions of refugees are still abroad, corruption, bribery, and injustice prevail, Afghan culture is under foreign domination, and there is no law and order.

There is no unity between the house and the senate, and the election commission has significant differences between the President of the Republic and the home. Irresponsible attacks of foreign forces continue on the defenceless villages and towns, and suicidal attacks kill many innocent people. Mr. Karzai is fighting with the united front and heroin production, and its illegal trade continues as before.

This unworthy governing group cares only for its interests, stamping the national interests; they do not believe in social equality, human dignity, human rights, purity, sincerity, honesty and patriotism. Instead, they struggle merely for power and money, cheating uninformed and ignorant people.

In recognition of the above problems and the fact that the destiny of the oppressed Afghan nation has been determined from abroad during the past thirty years. The national social code by which the country resolved its national problems by convening the traditional great national assembly (Loya Jirga) is no longer feasible.

The nation at this time cannot determine its destiny, nor can the foreign powers impose their will on the Afghan country. It is therefore essential that the Afghan nation, especially the Afghan intellectual group, those with purity, honesty, patriotism and experience, who have not stamped human rights and enjoy the trust of the United Nations, should take the initiative to implement the "Proposal for the Fundamental Changes in the Government of Afghanistan."

Taking into consideration the internal and regional conditions included in the proposal, it is emphasized that the views and findings of the United Nations mission consisting of 15 members, including the big powers, such as the USA, Russian Federation and the People's Republic of China, which has recently visited Afghanistan, should also be considered. It is expected that the mission has touched on the realities and the numerous problems Afghanistan has been facing during the past thirty years, as well as the foreign interferences in Afghanistan.

Before making a quick conclusion and decision, the mission should read the "Proposal for Fundamental Changes in the Government of Afghanistan," which suggests the convening of a national inter-Afghan conference and the Afghan representative national (Loya Jirga). Then after the approval of the security council submits its recommendations to the Karzi government and the coordinating committee of the inter-Afghan conference.

Mr. Hamed Karzai, the President of the Islamic Republic of Afghanistan, too, considers his conscious, moral, religious, Islamic and international obligations to protect his honour and the salvation of the motherland.

A country which he has inherited from his ancestors and which cannot tolerate misery and maltreatment anymore. He should accept that the forthcoming election based on the constitution is improper, unjust and in contradiction with the social justice, national interest of the country and the world's opinion.

It is therefore respectfully suggested that a different way should be sought, which is the "Proposal for Fundamental Changes in the Government of Afghanistan," by which the oppressed Afghan nation, as well as the entire world, would enjoy peace and comfort during the forthcoming years. In other words, based on article (64), item (8), chapter III of the constitution concerning (the Presidency) and chapter IX on (emergency), the President, after the approval of the national assembly, should declare a crisis in the country due to the reason of dominant insecurity, terrorism and suicidal attacks in many parts of the country.

He should demand from the United Nations the convening of the Inter-Afghan National Conference, as well as the Great National Representative Assembly (Loya Jirga).

A-Calling for inter-Afghan Conference.

1. Under the current challenging conditions, the traditional (Loya Jirga) cannot be convened; therefore, it is necessary to demand the moral and financial cooperation of the United Nations to invite and convene an Inter-Afghan Conference consisting of 400 Afghan patriotic scholars and intellectuals whose names have not been listed as violators of human rights. They would relatively represent the Afghan societies in and out of Afghanistan as a substitute for the traditional Loya Jirga (Representative Loya Jirga).

This group of 400 should then elect a group of highly educated and respected 100 Afghans by free, direct and secret voting from among themselves, supervised by a non-Afghan institution, trustworthy and acceptable to Afghans. The non-Afghan institution would manage and execute the election using a computer-based method. Finally, the elected group of 100 would form and convene the “Inter-Afghan Conference.”

2. The United Nations selected 20 neutral and nonaligned Afghan scholars by direct and secret computerized voting, performed by a non-Afghan institution trusted and approved by Afghans, to participate. Of the proposed 400 members, “Representative Loya Jirga.” Then six persons from these 20 persons will be selected by a similar computerized system to participate in the 100-member “Inter-Afghan Conference,” held in Kabul, the capital of Afghanistan.

The selected six persons will be then introduced to the special envoy of the United Nations as members of the “coordinating committee” of the 100 members “Inter-Afghan National Conference” so that under the United Nations auspices and financial aid, members of the proposed “Representatives Loya Jirga,” consisting of scholars and intellectuals are selected to begin their task force.

Members of the “coordinating committee” have equal rights and privileges of voting and candidacy like other members of the proposed “Inter-Afghan Conference” and “Representative Loya Jirga.” Therefore, the number of the members of the proposed “Representative Loya Jirga,” including the members of the “coordinating committee” and “Inter-Afghan Conference,” are introduced to be included as follows.

3. All the members of the Bonn Conference, representing the Rome Conference, Peshawar Conference, Cypress Conference and the Northern United Front.

4. The President of the National Assembly, his two assistants and the two secretaries of the National Assembly, and 25 members of the National assembly.

5. The President of the Senate, his two assistants and the two secretaries, together with ten members of the Senate.

6. Presidents of the Provincial Assemblies.
7. Ten people are representing the Taliban movement.
8. Ten people representing the Islamic Party of Hekmatyar.
9. Ten people represent the People's Democratic Party, with five from the "Khalq faction" and five from the "Parcham faction."
10. Ten people represent the "Jalaluddin Haqqani Party."
11. Twenty people represent the current Government Executive and Judiciary sections.
12. Sixty persons represent various Universities in Afghanistan. The Ministry of Higher Education will determine the number of each University concerning the number of Academic boards each.
13. Eighty persons representing various nonaligned and nonpartisan Inter-Afghan conferences held in America and Europe during the past seven years (the number of shares of each meeting will be determined concerning the number of participants in each panel).
14. Finally, about seventy people representing the Afghan Technocrats were included in the United Nations lists of 1993 and 1994.

B: Duties of the Proposed "Representative Loya Jirga"

1. 1. Selecting the members of the "Inter-Afghan Conference."
2. 2. Ratifying the resolutions of the "National Inter-Afghan Conference."
3. 3. With the exclusion of seventy-six persons (detailed in the duties of the "National Inter-Afghan Conference"), extending the existence and authorities of the current National Assembly and the Senate of Afghanistan for five years.

C: Duties and Functions of the Proposed "National Inter-Afghan Conference."

**The National Inter-Afghan Conference will be held in Kabul under a temporary Chairmanship of the special envoy of the United Nations, observing a special Islamic ceremony and will perform the following duties after the approval of the plan and procedure of the Conference.

1. Electing the President and two secretaries of the Inter-Afghan Conference by free and secret voting among three candidates.

2. Approving the Agenda and procedure of the Conference.
3. Discuss and make decisions on the following proposals.
 - To eliminate the regional crisis, Afghanistan should be recognized as a buffer state between the neighbouring countries so that neither Afghanistan attacks another country nor another country attacks Afghanistan, and Afghanistan should not be used as a means to attack another country.
 - Afghanistan should be recognized as a free, independent and non-aligned country, active and not indifferent.
 - Under the prevailing conditions, due to the lacking of sufficient military and police forces, Afghanistan cannot fight terrorists and foreign suicidal attackers. therefore it would be necessary to reform the Afghan National Army and Police based on the former (1978) tradition of two years of “National Obligatory Service.”
 - Security and stability are essential for implementing socio-economic-political programs; therefore, severe measures should be adopted to collect arms from armed civilians (NGOs) and warlords.

The Government should declare and warn that all forms of arms, excluding small pistols and hunting guns, must be returned to the Government free of cost or in exchange for food, clothing, agricultural seeds, fertilizers or industrial tools; otherwise, the Government would use force to collect the arms from the public and those not cooperating would be punished.

In Kabul, as well as other cities, arms should be collected from all civilians, warlords, Afghan and non-Afghan institutions and NGOs. Furthermore, the security of the towns, Government organizations, private institutions, foreign embassies, Consulates and commercial agencies should be guaranteed by the joint UN and Afghan forces based on bilateral agreements.

Parties not accepting the Government order should be seriously punished.

- Appointing an authorized commission among experienced Afghan experts to draft five-five years of developmental plans for 25 years with the cooperation of foreign Experts.
- Considering the socio-economic-military and human resources conditions of the country and the priorities. This plan should be prepared within six to nine months to be submitted to foreign investors and international institutions to attract foreign financial and technical aid to reconstruct Afghanistan’s infrastructure.
- Appointing twenty scholars consisting of economic, military, social and political experts by free and secret voting from the “Inter-Afghan National Conference” members to

be stationed at the United Nations in New York for five years. They will function as a bridge and liaison between the United Nations and the Government of Afghanistan for coordinating various functions.

- Creating a reasonable policy for avoiding the cultivation, processing and illegal sale and trade of opium; creating work and employment for the peasants engaged in such matters; tracing and punishing internal and foreign heroin dealers; implementing heavy punishments like those in Saudi Arabia on the dealers; encouraging landowners to cultivate such substitute as saffron, cotton, sugar cane, beetroot, horticulture, raising livestock, poultry, ice-making factories in the main cities and simple ones in the villages; using solar energy and small generators for creating energy; giving long-term loans for the realization of those projects: establishing agricultural Cooperatives and small factories for processing food items, fruits, candies and the like.
- Researching the claims of Afghanistan and the Russian Federation in connection to the former demand for the war compensation/reparation and the latter demand for the payment of the loans given to former puppet Governments and reaching a final solution under the auspices of the security council.

- A solid and final determination concerning amnesty or trial of the Afghan war criminals, violators of human rights and national traitors during the past thirty years.

- Searching for practical ways and means for the return of Afghan refugees from Pakistan and Iran and their settlement in uncultivated lands owned by the Government; giving each family a piece of land to build a house; building markets, health clinics, schools, police and security, digging deep wells, installing small diesel generators, building small factories and industries, etc. Under the supervision of the concerned ministry with the help of the world refugee and food organizations and initiating the work program for food.
- Providing settlement for Afghan Nomads (Kouchees) in various parts of the country, considering social justice and their living conditions; selling public lands under favourable terms at affordable prices and long-term payments and also issuing identification documents to the Nomads as a token to quit Nomadism.
- They are finding ways and means to financially support charity institutions such as (Small Islamic Bank) established in California, USA, (War-Torn Children and Ashiana) and the like for creating small industries like handmade items, arts and crafts and other low-priced items.

Such projects would benefit poverty, unemployment, orphans, widows and maimed persons to make them self-efficient and attract national and international aid.

- Drafting a socio-economic-political and military guideline valid for five years for the future Government of Afghanistan.
- Making a firm decision concerning candidate Afghans who have double Nationality and legalized dual Nationality for all Afghan refugees living in Europe, America, Australia and Elsewhere.
- Revision of the Constitution, if necessary.
- Provisions for the election of the President of the Republic and his two assistants, twenty cabinet members, considering their educational background, practical experience, courage in decision making, righteousness and honesty.

Selecting Provincial Governors from the 100 members of the “National Inter-Afghan Conference” by direct and secret voting from the three candidates for each position and giving preference to those Government candidates who are citizens of their respective provinces.

For example, among the three candidates for the Governor of Herat, priority should be given to those who have better education, piety, courage, education, and experience and who are committed to implementing the policies of the central government.

- Finally, all the decisions concerning the election and the articles mentioned above about the functions and duties of the “National Inter-Afghan Conference” would be submitted to “Representative Loya Jirga” for ratification. Members of the “National

Inter-Afghan Conference” and the “coordinating committee” will also participate in the “Representative Loya Jirga.”

- After the ratification of the decisions of the “National Inter-Afghan Conference” by “Representative Loya Jirga,” the present National Assembly and Senate would be dissolved, except for the members of the cabinet (20) and provincial Governors and twenty Afghan experts for the United Nations.
- Members of the “Representative Loya Jirga” would replace those dissolved for five years; the new President would choose his “Selective Representatives” from the members of the “Inter-Afghan Conference” under article (84), item (3) of the constitution; provincial assemblies each would elect a new chairman.
- At the “Representative Loya Jirga,” after the completion of the procedures for ratifying and dissolving during the two months of Hamal and Saour (March 21–May 21), the last day of Mr. Karzai’s Presidency is Saour 30th (April 21), under article (61), chapter III of the constitution; on the first day of Djouza 1388 (May 22, 2009) Mr. Karzai will transfer the powers to the new leadership and administration in an official ceremony.
- Mention must be made that from among living abroad, those who are selected to go to Afghanistan as members of the “Representative Loya Jirga” they should serve with righteousness, honesty, responsibility, concern for human rights, love and devotion for Motherland, caring for national interests and not for personal interests.

In addition, they should persuade and encourage other Afghans living abroad to return and serve their country with whatever means available. It is hoped that the Afghan Government or International Institutions will provide for the livelihood of those returning to perform in Afghanistan.

Your Excellency,

Indeed it is a great pleasure for my Afghan citizens and me to hear that your government will soon be hosting an international conference in Paris to discuss the outcome of the recent presidential election in Afghanistan, the future of Afghanistan and the international organizations working in the country.

There has been a great discussion, and a spotlight has been placed by the global community and the people of Afghanistan on issues such as widespread corruption in the current electoral process, along with views that both front runners in the presidential election have been associated with corruption, and that their government will be backed by or may include deemed warlords and alleged human right violations.

Accordingly, under such conditions and ill support of the first round of elections, it is clear that there is no hope and guarantees that either one of such candidates or the second round of the presidential election will be fruitful in bringing to power someone that will have the democratic support of the people of Afghanistan and be able to encourage peace and stability and move the country towards prosperity.

A PROPOSAL FOR FUNDAMENTAL CHANGES IN THE GOVERNMENT OF AFGHANISTAN BY ENGINEER FAZEL AHMED AFGHAN

A country which he has inherited from his ancestors and which cannot tolerate misery and maltreatment anymore. It is therefore respectfully suggested that a different way should be sought, which is the "Proposal for Fundamental Changes in the Government of Afghanistan," by which the oppressed Afghan nation, as well as the entire world, would enjoy peace and comfort during the forthcoming years. In other words, based on article (64), item (8), chapter III of the constitution concerning (the Presidency) and chapter IX on (emergency), the President, after the approval of the national assembly, should declare a crisis in the country due to the reason of dominant insecurity, terrorism and suicidal attacks in many parts of the country.

He should demand from the United Nations the convening of the Inter-Afghan National Conference, as well as the Great National Representative Assembly (Loya Jirga).

A-Calling for inter-Afghan Conference.

1. Under the current challenging conditions, the traditional (Loya Jirga) cannot be convened; therefore, it is necessary to demand the moral and financial cooperation of the United Nations to invite and convene an Inter-Afghan Conference consisting of 400 Afghan patriotic scholars and intellectuals whose names have not been listed as violators of human rights. 2. The United Nations selected 20 neutral and nonaligned Afghan scholars by direct and secret computerized voting, performed by a non-Afghan institution trusted and approved by Afghans, to participate. Of the proposed 400 members, "Representative Loya Jirga." Then six persons from these 20 persons will be selected by a similar computerized system to participate in the 100-member "Inter-Afghan Conference," held in Kabul, the capital of Afghanistan.

The selected six persons will be then introduced to the special envoy of the United Nations as members of the "coordinating committee" of the 100 members "Inter-Afghan National Conference" so that under the United Nations auspices and financial aid, members of the proposed "Representatives Loya Jirga," consisting of scholars and intellectuals are selected to begin their task force.

Members of the “coordinating committee” have equal rights and privileges of voting and candidacy like other members of the proposed “Inter-Afghan Conference” and “Representative Loya Jirga.” Therefore, the number of the members of the proposed “Representative Loya Jirga,” including the members of the “coordinating committee” and “Inter-Afghan Conference,” are introduced to be included as follows.

3. All the members of the Bonn Conference, representing the Rome Conference, Peshawar Conference, Cypress Conference and the Northern United Front.
4. The President of the National Assembly, his two assistants and the two secretaries of the National Assembly, and 25 members of the National assembly.
5. The President of the Senate, his two assistants and the two secretaries, together with ten members of the Senate.
6. Presidents of the Provincial Assemblies.
7. Ten people are representing the Taliban movement.
8. Ten people representing the Islamic Party of Hekmatyar.
9. Ten people represent the People’s Democratic Party, with five from the “Khalq faction” and five from the “Parcham faction.”
10. Ten people represent the “Jalaluddin Haqqani Party.”
11. Twenty people represent the current Government Executive and Judiciary sections.
12. Sixty persons represent various Universities in Afghanistan. The Ministry of Higher Education will determine the number of each University concerning the number of Academic boards each.
13. Eighty persons representing various nonaligned and nonpartisan Inter-Afghan conferences held in America and Europe during the past seven years (the number of shares of each meeting will be determined concerning the number of participants in each panel).
14. Finally, about seventy people representing the Afghan Technocrats were included in the United Nations lists of 1993 and 1994.

B: Duties of the Proposed “Representative Loya Jirga”

1. Selecting the members of the “Inter-Afghan Conference.”
2. Ratifying the resolutions of the “National Inter-Afghan Conference.”

3. With the exclusion of seventy-six persons (detailed in the duties of the “National Inter-Afghan Conference”), extending the existence and authorities of the current National Assembly and the Senate of Afghanistan for five years.

- Mention must be made that from among living abroad, those who are selected to go to Afghanistan as members of the “Representative Loya Jirga” they should serve with righteousness, honesty, responsibility, concern for human rights, love and devotion for Motherland, caring for national interests and not for personal interests.

In addition, they should persuade and encourage other Afghans living abroad to return and serve their country with whatever means available. It is hoped that the Afghan Government or International Institutions will provide for the livelihood of those returning to perform in Afghanistan.

We seek help from Almighty God for success.

Your Excellency,

I consider it a great honour to say that your strategy for Afghanistan, as recently addressed to the people of the United States and the world, has touched me very much.

Therefore, it is a great honour for me to congratulate Your Excellency. Indeed it is a great pleasure for me to express myself and say that there are some other important issues as well that need to be addressed by your kind administration in cooperation with the future new administration in Kabul, Afghanistan and are outlined as follows:

1. To eliminate the regional crisis, Afghanistan should be recognized as a buffer state between its neighbouring countries. Neither Afghanistan nor a neighbouring country attacks one another, and nor should Afghanistan be used as a means to attack another country.
2. Afghanistan should be recognized as a free, independent and active non-aligned country.
3. Under prevailing conditions and a lack of sufficient military and police forces, Afghanistan cannot adequately combat terrorists and foreign suicide attackers within its borders. Therefore, it would be necessary to allow only a global power under the supervision of the United Nations to remain in Afghanistan for five to six years to assist in this fight.
4. The Afghan national army and police force should be reformed based on former tradition (pre-1978) in the country whereby two years of obligatory national service was required.
5. Appoint an authorized commission composed of experienced Afghan topical experts with the mandate to draft a five-year development plan.
6. Creating a reasonable policy that helps prevent the cultivation, processing and illegal sale and trade of opium.
7. Finding a solution for the problem identified as "Pashtunistan," as Pashtuns are our brothers sharing the same language, culture and traditions. Unfortunately, this land was separated from Afghanistan by force, and an imposed line was drawn to separate the two brothers.

However, today we want a choice of self-determination for the Pashtun and Baloch brothers and sisters, thereby preserving the territorial integrity of Afghanistan. Therefore, we want to resolve the problem of the imposed Durand line through peaceful negotiation with Pakistan, with direct participation from representatives of the governments of Afghanistan and Pakistan along with Pashtun and Baloch representatives, all under the direct auspices of the United Nations.

8. The \$1.2 billion a year allocated to Pakistan should be directly spent to support the development of Pashtun and Baloch territories and not for Pakistan's arms and nuclear forces.

9. We Afghans want a strong central government that has complete control over each province.

Therefore, if any financial or technical assistance is extended from a donor country or organization, it should be with the collaboration of the central government, whereby the provincial government is accountable to the central government and the donors for each penny spent.

Thank you for your kind attention, and I would like to take this opportunity to renew to Your Excellency the assurance of my highest consideration.

PEACE PLAN TO EXTINGUISH THE IMPOSED ABLAZE FIRE IN AFGHANISTAN

Dear learned and intellectual fellow Afghans,

I am honoured to be standing here at such a valuable and timely conference with the opportunity to present a plan for peace for our motherland Afghanistan.

Due to time constraints, I do not intend to describe the events of the last 31 years in Afghanistan in detail. However, I only briefly mention that the bloody coup d'état of April 27, 1978, marked the beginning of the miseries our society has endured over the years, along with the ignition of flames of war that has transformed our motherland into a bloodbath with the bloodshed of her innocent children and created a path of destruction which has flattened clear homes.

Unfortunately, three decades of such pain and suffering have passed. But unfortunately, the flames of such fire have been on the rise due to the continuation of war and terror, with the oppressed people of Afghanistan marching in darkness towards an unknown future.

Eight years ago, with the commencement of the Bonn Conference, the people of Afghanistan had given a glimmer of hope with the establishment of a temporary and transitional government and then an elected President that the people were looking to for a free and prosperous country. But unfortunately, despite all their hopes and dreams, the social, economic, political and national security situations in Afghanistan did not materialize nor stabilize as expected.

Once again, in 2009, the oppressed people of Afghanistan who were counting on transparency in the second term of Presidential elections to find an elected leader and saviour for the nation who could eliminate their miseries and put their country once again on the forgotten path of prosperity were disappointed. They, unfortunately, witnessed the “reappointment” of President Hamid Karzai as the outcome of a shameful election resulting from fraud, corruption and negotiations with foreign powers behind closed doors.



Their hopes and aspirations vanished into thin air with the realization that they would have to live with the same old administration for the next five-year term and that their destiny would be in the hands of foreign sponsors and President Karzai.

The latter would be dining at the same table with an administration that includes certain human rights violators, corrupted warlords and narcotic farmers. In effect, the status quo and the dire situations of the past 30 years prevail.

Dear brothers and sisters, as the brave Afghan nation has moved beyond but not to be forgotten results of the second term Presidential elections with the knowledge or involvement and negative influence of the corrupt and ill-willed as noted above that was the source of creating and imposing an unqualified regime in our dear country, it is now our Islamic, patriotic, national and conscience responsibility as intellectuals to take urgent, positive and effective action to save and bring back our motherland to the once free nation which we inherited from our ancestors.

This sacred dream can only be realized when our patriotic, civil and religious intellectuals who are the anchor of hope for the orphans, widows, disabled, homeless, the ill who live with hunger, poverty and insecurity inside Afghanistan and for those Afghan refugees who live in the camps and slums of Iran and Pakistan take action without prejudice and discrimination. Therefore, for the sake of God and in recognition and honour of the millions of martyrs who lost their lives for our country, our dignity, righteousness and fight for freedom; let's set aside our selfishness, thirst for power, worshipping personalities; and instead I urge you to fill your hearts with the love of patriotism, the worship of God and to work together for the good of our Afghan nation, our neighbours and the world.

This would involve us working in cooperation with severe and honest intent and coming together in unity with the might of an iron fist to identify solutions that would end our country's ongoing crisis.

Working together in a peaceful and productive environment to reach a working resolution and plan that would be proposed as an "Afghan Peace Initiative" at the upcoming International Conference in London and an Inter-Afghan Conference in Kabul.

Such a proposal involving solutions to current issues facing Afghanistan needs to be considered in the context of both domestic and international parameters, with appropriate resolutions being brought forth so that we can, By the will of God and respect for Islamic values, save our homeland from occupation and transform it into a free, independent and prosperous country that supports peace, security and the rule of law.

We, therefore, need to present this "Afghan Peace Initiative" for consideration first at the prospective International Conference to be convened in London this month through the office of the United Nations.

Then, after review and consideration of the proposed plan and in light of the decisions and conclusions of the said International Conference, the proposal should be discussed in an

Inter-Afghan Conference in Kabul before the Grand Assembly (Loya Jirga) proposed by President Karzai, which would include a legitimate group of Afghan representatives but excluding those who have caused bloodshed and been involved with the violation of Human Rights.

Finally, to emerge from the above Afghan conference with decisions and a clear path to save our motherland from the ongoing crisis and create a national government that will bring peace to our beloved nation.

Thereby with your permission, the honourable dignitaries and patriots, brothers and sisters, I would like to share with you my views for your consideration as we set forward today to bring together a peace plan to be discussed at the International as well as at the proposed Inter Afghan Conference:

A. Seven Point Proposal to be tabled at the International Conference in London.

I want to share with you my seven-point proposal first, starting with and discussing President Obama's 3-point strategy on Afghanistan:

1. The deployment of an additional 30,000 American troops would add no further benefit to the current situation but rather be a continuation of irresponsible killings of innocent people and would undermine our Afghan national pride; especially that of our Pashtoon and Baluch brothers and sisters living on both sides of Durand Line.

I, therefore, propose to prioritize the creation of a well-trained instead equipped national army and national police over the next two years. This will coincide with the departure of limited American contingents, as proposed by President Obama, independent of the 70,000 American troops currently in Afghanistan. This is with consideration that the cost incurred for one American trooper is equal to that of 60 Afghan soldiers; in exchange for the additional deployment of 30,000 American troops.

We can train 1,800,000 Afghans to form a national army and the national police that are well equipped. Therefore, while such a significant force for Afghanistan is not needed, it is suggested that the United States spend a quarter of the associated costs of the additional troops, which would prepare a force of approximately 450,000 professionally trained and equipped Afghan army and police personnel to look after the national security, sovereignty and public safety all over the country.

This can indeed happen over the next two to four years before completing President Karzai's term. If such a proposal is implemented, there will be no need for foreign troops to stay beyond four years, and there will be no need to create the already tested destructive militia forces in Afghanistan.

Another benefit of this strategy would be that the United States, by way of reduction of their military expenditures, could invest in the most needed social, economic and military infrastructure of Afghanistan in cooperation with a powerful and centralized Afghan government to gradually develop a society based on genuine democracy and one in line with the social conditions and values of the people of Afghanistan.

To accomplish this strategy, the national army and police will be formed regarding the compulsory military service arrangement that was in place before the bloody coup of April 27, 1978. With this measure in place, the youth from all over our great country, with the support of the whole Nation, can form a unified iron fist to defend the rights, freedom and sovereignty of the country.

To utilize the experiences and dedication of the current and honorary army and police members that may not have the appropriate skills for military and security service, such individuals could be allowed to participate in other proposed organizations of government such as the Public Workforce and Public Green force in the Ministry of Public Works and Ministry of Agriculture with the cooperation of ISAF (the International Security Assistance Force) to accelerate the development of the country.

2. President Obama's plan to direct financial aid to the provinces and local leaders without the accountability of such provincial governments to a powerfully stable and centralized Afghan government, along with the idea of establishing, arming and financially supporting provincial militia forces, needs to be addressed. This not only weakens the central government but would cause a repeat of the bitter and divided experiences the country has faced historically.

Additionally, the pretext of autonomy for the provinces will result in continued warfare that will drag our motherland and her innocent people into unperceivable turmoil.

Therefore, if the foreign powers and President Obama have honest intention to benefit the long-run prosperity of Afghanistan, I present for discussion now and for the proposed Inter-Afghan Conference that instead of offering aid directly to the provinces and local leaders, the United States should implement the proposed fundamental changes that would establish and support a strong central government which in turn would direct and hold accountable the provincial governments and leaders for the benefit and long-run prosperity of the country.

3. President Obama's administration has been increasing aid to the Pakistani government without accepting that Pakistan has continued to use the American government as a cash cow. Pakistan has used a variety of deceptions and excuses to receive substantial funding from the American government. It has indeed used such funding for its interests and against that of American, Afghan and Indian interests.

President Obama has indicated and should follow through as a priority to pressure and hold accountable Pakistan's government to prevent Pakistan's ISI from participating and pursuing its inhumane activities in Afghanistan.

President Obama's Administration has promised aid to Pakistan with the title and intent of crushing the terrorists, particularly al-Qaeda's activities across the border on the so-called Durand Line.

However, the result of such assistance will only lead to the Pakistani government using the funds to wage war against our innocent Pashtoon, Baluch brothers and sisters, including our Afghan immigrant brothers and sisters across the border in Pakistan and with the pretext of dealing with terrorism, will disperse the terrorists like ants all over Afghanistan and neighbouring regions so that they can continue to pursue their inhuman and un-Islamic activities and be a threat to the area and the world.

It is therefore proposed to exert continued and targeted pressure on the Pakistani government and have them commit to a plan to extinguish the ISIs, al-Qaeda's and other terrorist groups' relations with their supporters by cutting off their financial aid and arms.

The US government should no longer present a blank cheque to Pakistan but rather hold them accountable in return for assistance.

As part of exerting pressure and taking a further active role with Pakistan, the United States should target and station a significant portion of the foreign forces in Afghanistan close to the so-called Durand Line, as this is a central source of terrorism.

Additionally, in the International Conference, Afghanistan's neighbouring countries should be strongly encouraged to stay away from destructive interference in Afghanistan's domestic affairs.

They should be further assured that Afghanistan wishes to have peaceful relations with all peace-loving countries and wants to have unique cordial relations with its Islamic and neighbouring countries.

4. Establishing peace in Afghanistan and the region requires the recognition of Afghanistan as a buffer state among its neighbouring countries with the resolution that Afghanistan wouldn't invade any neighbouring country, nor would neighbouring, or foreign countries invade Afghanistan nor use its soil as a platform to attack other countries.

5. One of the key justifications for foreign troops' existence and mission in Afghanistan is to combat terrorism. Therefore it is proposed that the term "terrorism" be defined in the International Conference following International law to clarify the actions that would fall under terrorism.

After that, within the said definition, the Afghan National Army and Police, along with foreign forces, can jointly carry on their legitimate duties of fighting terrorism without killing innocent people or destroying their homes. This is crucial to shed light and provide direction on a critical mission and one that would allow targeted focus on the areas that pose such a threat.

6. The following outlines another point that would support our sovereignty and ability to operate under the Afghan rule of law effectively. I propose that all foreign prisons in Afghanistan be shut down orderly. Instead, all Afghan prisoners are transferred to Afghan-controlled prisons together with their records so that their cases can be reviewed and evaluated by Afghan courts of law.

7. Lastly, as noted, it is vital that, in addition to the International Conference in London, such matters be proposed and discussed with the key stakeholders in Afghanistan via a proposed Inter-Afghan Conference.

It should be agreed and ratified that such a conference involve and be open to legitimate representatives of all political parties, including opposing President Karzai's administration. It is also essential that a cease-fire be implemented before the said Conference to establish a venue of open dialogue, cooperation and peace.

The Afghan government should collaborate with and support the UN representative in Kabul to establish such a conference and ensure the logistical and security arrangements are made to allow for a peaceful and productive dialogue.

B. Proposal to be discussed at an Inter Afghan Conference

My fellow Afghans, we are all directly or indirectly aware of the proceedings and downturn of the past eight years in our country, along with the presidential election of Aug. 20th, 2009, which involved negotiations with foreign powers behind closed doors.

Accordingly, I believe that the current dire situation is not a solution to our problems and, if continued, will carry devastating consequences that may not be rectifiable. If the government's opposition is under the belief that ongoing war and killings will be the pathway to peace, they are seriously mistaken.

Some people believe that the calling of the traditional National Grand Assembly (Loya Jirga), which makes crucial and strategic decisions concerning national issues at present, is the solution for today's crisis and one that would defuse the flames engulfing our country.

Here, I should remind you that due to the demise of our national unity over the past three decades, the Grand Assembly (Loya Jirga), as once intended, would not operate effectively under current circumstances but rather operate in the same "ceremonial" manner as the Grand Assembly that resulted in the appointment of President Hamid Karzai as the President of the Transitional Government of Afghanistan.

Therefore, under the dire prevailing situations as the oppressed nation and the patriotic scholars, in particular, are set forth to an essential and historic task; we need to ensure that the direction we take is in line and complies with the provisions of our constitution as adopted by President Karzai's government as well as supported by the international community.

Therefore, I set forth for your consideration the following proposal for fundamental changes in the government of Afghanistan, which is following the terms of our constitution.

While it may be difficult to swallow and like drinking a glass of poison to accept the legitimacy of President Karzai's recent election; under the current challenging and fragile situation our country is facing, we should be open to receiving President Karzai up until the calling of the Grand Assembly (Loya Jirga) in two years as proposed by President Karzai. This will also coincide with the commencement of the departure of American troops, as indicated by President Obama.

Furthermore, we should make such a compromise and adopt an inclusive policy that allows for negotiation with the government's opposition and also opens the door for the participation of their legitimate delegates in the proposed Interim Afghan Conference to enable us to find practical ways to establish peace for a prosperous and free Afghanistan.

Also, by submission of the above plan, we can convince the intervening international forces at the International Conference that the continuation of war under different names is not the solution.

So we had better jointly seek ways to get out of the deadlock and prepare grounds for the gradual and dignified departure of all foreign troops within the next four years, based on a departure schedule accepted by the Afghan government and the world.

This way, we can jointly attempt to create a relatively national government, free of today's administrative corruption, for an independent, free and non-allied country which can be a friend and suitable partner with the international community. This can materialize from the beginning of the second round term of President Karzai, which comprises a two-year transitional period or maybe a full five-year term in office.

This dream will only be realized if the loose thread currently connecting President Karzai with the international forces is kept intact. But unfortunately, such a fragile tie could be cut off at any time due to conflicts between the Afghan and international governments.

Our hopes for a more robust and peaceful Afghanistan can only come true if we stabilize this thread by bringing together several virtuous, honest and patriotic Afghan scholars to liaise in the middle of such a line for the above-mentioned two-year transition period. This will allow them to strengthen and take control of the fragile situation and be in the best position to negotiate with the respective parties about any possible resolutions relating to the elimination of the current crisis and the creation of a promising future for Afghanistan.

Another critical goal over the said two-year transition period would be the integration of all currently registered parties and the creation of two representative national political parties that would start working towards inclusive participation in the prospective national Grand Assembly (Loya Jirga) and the creation of a proper federal government.

For the success of this grand objective, it is necessary to open the door for negotiations with the government's opposition, including leaders of the opposition such as Mr. Golbaddin Hekmatyar, Mr. Jalalluddin Haqani and Mr. Mulla Mohammad Omer, with the understanding that war is not the solution for peace and freedom in Afghanistan.

Therefore, these opposition leaders should be invited to introduce their authorized representatives to participate in the proposed Inter-Afghan conference to be convened in Kabul with the commitment that a ceasefire must be adopted during such time to allow for productive and peaceful discussions.

Therefore, I suggest the appointment of a delegation consisting of the following individuals be commissioned to meet with the opposition leaders at their earliest convenience and at a mutually agreed-upon venue to invite the opposition to introduce their virtuous and patriotic representatives whose hands are not stained with the blood of Afghans:

My suggested delegation of respected individuals to negotiate with the opposition leaders is as follows:

1. Mr. Seyed Ahmad Gilani
2. Dr. Abdulsattar Sirat
3. Dr. Farough Aazam
4. Mr. Seyed Jalal Karim
5. Mr. Golagha Shiroozi
6. Mr. Mohtasebollah Mazhabi

With your permission, the following will set out the essential points about the proposal for fundamental changes to be discussed at the proposed Inter-Afghan conference to be convened according to the International Conference in London with the hopes of establishing peace and prosperity in our adored motherland.

Firstly, according to the resolutions and agreements reached by the International Conference and in line with the terms of item 20 of section 64 from chapter four of our Constitution; His Excellency, President Hamid Karzai, the President of the Islamic government of Afghanistan, ordered the Elections Commission to establish the following two commissions in Kabul:

1. The High Executive and Parliamentary Council
2. The High Council of the Professionals and the Auditor General
3. The High Executive and Parliamentary Council.

Such a Council would comprise approximately 400 intellectual Afghans living inside and or outside of the country who have no criminal records and haven't been implicated in any violation of human rights. This Council would be established under item 5, section 158 of chapter 12 of the Constitution and its members be elected or appointed as outlined in the following section under the supervision of the Elections Commission and UN representatives: Members of High Executive and Parliamentary Council

1. All members of the Bonn Conference, representing the Rome Conference, Peshawar Conference, Cypress Conference, Afghan Mellat, and the Northern United Front, will be included.
2. President, two vice presidents and two secretaries of Parliament.
3. Thirty-four members from Parliament for representation of thirty-four provinces...
4. President, two vice presidents and two secretaries of the Senate.
5. Thirty-four members from the Senate for representation of thirty-four provinces.
6. Ten representatives from the Taliban movement.
7. Ten representatives from the Islamic Party of Mr. G. Hekmatyar.
8. Ten representatives from the "People's Democratic Party, later called Watan," including five from Parcham and five from Khalq.
9. Ten representatives from Jalaluddin Haqqani Party.
10. Sixty representatives from the faculty members of Universities throughout Afghanistan.
11. Eight representatives from various non-aligned and nonpartisan InterAfghan conferences held in America, Europe and Australia during the last several years.
12. Seventy people from Afghan Technocrats were included in the United Nations list issued in 1993/1994.
13. All 34 Chairs of the Provincial Councils throughout Afghanistan. The Council will be established to pursue the following mandate:
 - Establishment of peace, national unity and national compromise for a free, independent, united and sovereign Afghanistan,
 - Establishment of the rule of law, equity and equality of women and men and justice to develop and strengthen the present system,
 - Formation of a self-sufficient national army and police to defend the federal and territorial sovereignty of the country and maintain peace in the country,
 - Gradual development and promotion of democracy in line with the view of the country's social climate and values,

- Laying the foundation for the formation of two representative national political parties,
- Promoting the establishment of cooperation and coordination among the three branches of the State,
- Serious cooperation with the High Council of Experts and Professionals and with the Auditor General to champion professional and expert standards across all areas of government operations,
- Uprooting fraud in the administration,
- Development of equal education with high standards in consideration of Afghan culture for all Afghans,
- Establishing and encouraging cordial relations with all peace-loving nations of the world,
- Advocating the fight to eradicate the roots of terrorism in the country, and
- Creation of strong and healthy Executive and Parliamentary branches of the state acceptable to the Afghan and international communities.

Appropriate efforts must be made so that without prejudice and hostile intentions, the clergy, scholars, distinguished citizens, representatives of the opposition, members of the national parliament, technocrats, provincial representatives and presidential candidates be chosen to exhibit national representation and one that is viewed positively internationally.

The following is a brief description of the start-up procedures for the High Executive and Parliamentary Council, which will later transition into two separate organizations forming the Executive and the Parliamentary branches of the state:

A. The High Council should initially convene with consideration of Islamic and Afghan traditions and with the interim chairmanship of the Special Representative of the General Secretary of the United Nations. Immediately after that, a virtuous, learned, experienced and patriotic person with a postgraduate degree should be elected as the High Council chair replacing the interim chair through a direct, free and confidential vote.

B. The council shall then, under the direction of the Council Chair utilizing a direct, free and confidential ballot elect a deputy and two secretaries from candidates that have virtue, who are learned, patriotic, experienced and hold a postgraduate degree.

1. Description of Duties for the High Executive and Parliamentary Council

Due to time constraints, I would like to share with you a summary and focal points of their duties as follows:

Effective execution of the above proposals requires an effective, qualified, working and honest Executive Council that can be trusted by the Afghan people and by the broader international community.

Therefore, it is necessary that the virtuous Afghans and the dynamic international forces who are engaged in Afghanistan and who wish to realize national unity, peace, compromise, an extinguishment of fraud and terrorism, the rule of law, equal rights and true democracy in Afghanistan to raise their voice in a friendly and respectful manner and ask the first and second vice presidents to submit their resignation to His Excellency President Hamid Karzai for the sake of God, national peace, compromise and in the utmost interest of the oppressed people of Afghanistan.

Next, for President Karzai to accept their resignation in line with allowable rules of our constitution in line with item number ten, section Sixty-four of chapter three of the constitution allow the High Executive and Parliamentary Council to elect two qualified patriotic persons of virtue and honour, holding a postgraduate degree and who believe in a stable and efficient central government through a free, direct and confidential ballot and to introduce them to the president for appointment.

Consequent to the said appointments by the President, one of the appointees will be assigned the First Vice President and chair of the Executive Branch and the other as the Second Vice President and chair of the High Council of the Experts/Professionals in the Department of the Auditor General. After the appointment of the vice presidents, the cabinet of President Karzai for the well-being of the nation should resign so that the High Executive and Parliamentary Council can choose and appoint new members of the cabinet that are virtuous, learned, experienced, professional, highly educated and patriotic from within members of the High Executive and Parliamentary Council and from the resigned members of President Hamid Karzai's cabinet and then subsequently introduce them to President Karzai for appointment under item number 11, section 64 of chapter three of Afghanistan's constitution.

After that, 34 people may include members of the High Executive and Parliamentary Counsel and the resigned members of the cabinet who are also highly educated, experienced, honest, patriotic, of good reputation amongst the people and true believers in the benefits of a strong central government should be elected and introduced to President Karzai appointed as the governors of the provinces under item number 13, section 64 of chapter four of the constitution.

Further, two deputies from the members of the High Executive and Parliamentary Counsel should be elected by free, direct and secret ballot and be introduced by the Second Vice President to President Karzai as deputies for the High Council of the Experts/Professionals and the High Council of the Auditor General.

While Sections 83 and 84 of chapter five of the constitution explicitly state that the parliament and senate elections include one person from each district council and that the polls from the provinces and districts be based on the proportionate population of each province and district.

However, due to the lack of security, a national census and citizenship certification, all of which are required to hold such elections, district council elections have not been held.

Therefore, due to the nonexistence of such district elections, the due process for the parliament and senate elections has not been carried out, making the first round and upcoming national assembly unlawful and in contradiction to the constitution's requirements.

Accordingly, it is proposed that until the restoration of security is restored across the country to allow for completion of a census, issuance of citizenship cards and district council elections that the national assembly elections be postponed and alternatively temporarily substituted by the creation of the 400-member High Executive and Parliamentary Council consisting of the Executive Council (two vice presidents, cabinet, provincial governors and deputies of the Experts Council and the Auditor General) and Parliamentary council which would consist of the remaining 400 members and act as the interim parliament.

This interim parliament shall, after having chosen its chair, deputies and secretaries through a free, direct and secret ballot under section 156, chapter 11 of the constitution, under the supervision of the elections commission and by the presidential decree, assume the role of the national assembly during the two-year transition period up until the next official elections for the national assembly

2. The High Council of Experts, Professionals and the Auditor General

The leading organizations of the Experts and the Auditor General, known as the Chief of the Experts and Chief of the Department of the Auditor General, will incorporate a joint high-level board under the chairmanship of the second vice president. However, they shall operate separately within their charter and due regulations.

A. The Chief General/Chairman of the Experts/Professionals

The Chief General of the Experts/Professionals should comprise Afghan and international skilled professionals in technology, engineering, finance, planning, education, arts and other critical social, economic, political and military services. Furthermore, under its constitution and due regulations, it should cooperate with the three branches of the state and the Chief Auditor General to provide the necessary skills, expertise and guidance to improve the level of quality and efficiency in the operations of the government.

B. The Chief General/Chairman of the Department of the Auditor General

The Chief General of the Auditor General's office should comprise of honest, virtuous, learned and patriotic individuals with knowledge of accounting, finance and administration, which should work together and cooperate with the three branches of the state and the Chief General of the Experts at the federal level and with the regional, provincial levels as well to aid accountability, improve the administration's financial systems and to establish a high quality, modern, accountable and transparent administration, free of corruption and that can be trusted by the Afghan nation and the international community.

As I conclude, with great hopes, I wish for success for this Afghan Conference to discuss and find a path for peace for our motherland. I want to emphasize that no one can rebuild our destroyed country except for the wise, learned, virtuous and patriotic Afghans and thus, it is in our hands to take on this critical task. I also sincerely hope this won't be the last conference of this type and that its resolutions will not be shelved or ignored but seriously pursued by a central and robust organization of the learned, and one that continues to keep our Afghan brothers and sisters updated on the progress and activities of such an organization. With the success and efforts of this gathering,

I propose that a strong central committee consisting of our dear fellow Afghans who have initiated this conference at Hayward, California, establish a branch office in Kabul and other areas of the world where Afghans reside and continue their outstanding efforts and commitments for peace and to promote prosperity, sovereignty and freedom for our motherland at the national and international levels through peaceful relations. Finally, I hope our learned and distinguished Afghans act in the same way as the sunshine that views our Afghan brothers and sisters equally with one eye and like the moon that throws light at every darkness of our adored motherland Afghanistan; so that with the mercy of God, the Afghan nation will no longer be a burden on the shoulders of others and that our government will rise from the rubbles of war, rebuild the country with its own hands and stand up for its rights. I want to end by wishing everyone a happy New Year and hope for peace and prosperity for all nations, including our beloved motherland Afghanistan.

Dear and Respected Friends,

Since this is the last year of President Obama's second term, I would like to draw your kind attention to my proposal to Mr. Obama, which I sent just before he became the President of the United States. It showed that purity, sincerity, honesty, knowledge, patriotism and broadmindedness are qualities which constitute the character of Mr. Obama and gained him success in the election at both national and international levels.

In addition, he stood free of the old and unpopular contradictions and forgotten inhuman values. Unfortunately, the oppressed nation of Afghan would, once again, face a vital national trial. Contrary to what we observed in the American election, several unworthy personas are planning to hold an election using slogans of ethnic, religious and regional phrases and cheating people by misinterpreting the articles of the constitution.

Their goal is to collect votes from illiterate, uninformed and ignorant people to establish themselves as winners. This is happening at a time when the national infrastructure is being destroyed. The nation is fighting an imposed war, the census has not been taken, local consultative assemblies have not been established, security does not exist, millions of refugees

are still abroad, corruption, bribery, and injustice prevail, and Afghan culture is under foreign domination.

There is no law and order in the country. There is no unity between the house and the senate, and the election commission has significant differences between the President of the Republic and the home. Irresponsible attacks of foreign forces continue on the defenceless villages and towns, and suicidal attacks kill many innocent people. Mr. Karzai is fighting with the united front, and heroin production and its illegal trade continue as before.

This unworthy governing group cares only for its interests, stamping the national interests; they do not believe in social equality, human dignity, human rights, piety, sincerity, honesty and patriotism. They are struggling merely for power and money, cheating uninformed and ignorant people.

In recognition of the above problems and the fact that the destiny of the oppressed Afghan nation has been determined from abroad during the past thirty years. The national social code by which the government resolved its national problems by convening the traditional great national assembly (Loya Jirga) is no longer feasible. The nation at this time cannot determine its destiny, nor can the foreign powers impose their will on the Afghan government. It is therefore essential that the Afghan nation, especially the Afghan intellectual group, those with piety, honesty, patriotism and experience, who have not stamped human rights and enjoy the trust of the United Nations, should take the initiative to implement the "Proposal for the Fundamental Changes in the Government of Afghanistan."

Taking into consideration the internal and regional conditions included in the proposal. It is emphasized that the views and findings of the United Nations mission consisting of 15 members, including the big powers, such as the USA, Russian Federation and the People's Republic of China, which has recently visited Afghanistan, should also be considered.

It is expected that the mission has touched on the realities and the numerous problems Afghanistan has been facing during the past thirty years, as well as the foreign interferences in Afghanistan.

Before making a quick conclusion and decision, the mission should read the "Proposal for Fundamental Changes in the Government of Afghanistan," which suggests the convening of a national winter afghan conference and the Afghan representative national (Loya Jirga).

Then after the approval of the security council, it submits recommendations to the Karzi government and the coordinating committee of the inter-Afghan conference. Mr.Hamed Karzai, The President of the Islamic Republic of Afghanistan, too, considers his conscious, moral, religious, Islamic and international obligations to protect his honour and the salvation of the motherland. A country which he has inherited from his ancestors and which cannot tolerate misery and maltreatment anymore.

He should accept that the forthcoming election based on the constitution is improper, unjust and in contradiction with the social justice, national interest of the country and the world's opinion. It is therefore respectfully suggested that a different way should be sought, which is the "Proposal for Fundamental Changes in the Government of Afghanistan," by the implementation of which the oppressed Afghan nation, as well as the entire world, would enjoy peace and comfort during the forthcoming years. In other words, based on article (64), item chapter III of the constitution concerning (the Presidency) and chapter IX about (emergency), the President, after the approval of the national assembly, should declare a crisis in the country due to the reason of dominant insecurity, terrorism and suicidal attacks in many parts of the country.

Therefore, he should demand from the United Nations the convening of the Inter-Afghan National Conference, as well as the Great National Representative Assembly (Loya Jirga).

A: Proposed "Representative Loya Jirga"

1. Under the current challenging conditions, the traditional (Loya Jirga) cannot be convened; therefore, it is necessary to demand the moral and financial cooperation of the United Nations to invite and convene an Inter-Afghan Conference consisting of 400 Afghan patriotic scholars and intellectuals whose names have not been listed as violators of human rights.

They would relatively represent the Afghan societies in and out of Afghanistan as a substitute for the traditional Loya Jirga. So-called (Representative Loya Jirga) This group of 400 should then elect a group of highly educated and respected 100 Afghans by free, direct and secret voting from among themselves, supervised by a Non-Afghan institution, trustworthy and acceptable to Afghans.

The Non-Afghan institution would lead and execute the election using a computer-based method. The elected group of 100 would form and convene the "Inter-Afghan Conference."

Further details in this connection follow:

2. It may be advisable if the United Nations select 20 neutral and non-aligned Afghan scholars by direct and secret computerized voting, performed by a NonAfghan institution trusted and approved by Afghans, to participate in the proposed 400 members "Representative Loya Jirga."

Then six persons from these 20 persons will be selected by a similar computerized system to participate in the 100-member "InterAfghan Conference," held in Kabul, the capital of Afghanistan. The selected six persons will be then introduced to the special envoy of the United Nations as members of the "coordinating committee" of the 100 members "Inter-Afghan National Conference" so that under the United Nations auspices and financial aid, members of the proposed "Representatives Loya Jirga," consisting of scholars and intellectuals are selected to begin their task force. Members of the "coordinating committee" have equal rights and privileges of voting and candidacy like other members of the proposed "InterAfghan Conference" and "Representative Loya Jirga."

The number of the members of the proposed “Representative Loya Jirga,” including the members of the “coordinating committee” and “Inter-Afghan Conference,” are introduced to be included as follows:

3. All the members of the Bonn Conference, representing the Rome Conference, Peshawar Conference, Cypress Conference and the Northern United Front.
4. The President of the National Assembly, his two assistants and the two secretaries of the National Assembly, and 25 members of the National assembly.
5. The President of the Senate, his two assistants and the two secretaries, together with ten members of the Senate.
6. Presidents of the Provincial Assemblies.
7. Ten persons representing the Taliban movement.
8. Ten persons are represented by the Islamic Party of Hekmatyar.
9. Ten persons representing the “Peoples Democratic Party,” five from “The Khalq faction,” and five from “The Parcham faction.”
10. Ten persons representing the “Jalaluddin Haqqani Party.”
11. Twenty persons representing the current Government Executive and Judiciary sections.
12. Sixty persons representing various Universities of Afghanistan. The Ministry of Higher Education will determine the number of each University about the number of the Academic boards of each University.
13. Eighty persons representing various non-aligned and nonpartisan InterAfghan conferences held in America and Europe during the past seven years (the number of shares of each meeting will be determined by the number of participants in each conference).
14. Finally, about seventy persons representing the Afghan Technocrats were included in the United Nations lists of 1993 and 1994.

B: Duties of the Proposed “Representative Loya Jirga”

1. Selecting the members of the “Inter-Afghan Conference.”
2. Ratifying the resolutions of the “National Inter-Afghan Conference.”
3. With the exclusion of seventy-six persons (detailed in the duties of the “National Inter-Afghan Conference”), extending the existence and authorities of the current National Assembly and the Senate of Afghanistan for five years.

C: Duties and Functions of the Proposed “National Inter-Afghan Conference”:

The National Inter-Afghan Conference will be held in Kabul under a temporary Chairmanship of the special envoy of the United Nations, observing a special Islamic ceremony and will perform the following duties after the approval of the plan and procedure of the Conference.

1. Electing the President and two secretaries of the Inter-Afghan Conference by free and secret voting among three candidates.
2. Approving the Agenda and procedure of the Conference.
3. Discussing and making decisions on the following proposals.
 - i. To eliminate the regional crisis, Afghanistan should be recognized as a buffer state between the neighbouring countries. So that neither Afghanistan attacks another country nor another country attacks Afghanistan, and Afghanistan should not be used as a means to attack another country.
 - ii. Afghanistan should be recognized as a free, independent and non-aligned country, active and not indifferent.
 - iii. Whereas under the prevailing conditions, due to the lacking of sufficient military and police forces, Afghanistan cannot fight the terrorists and foreign suicidal attackers. Therefore, it would be necessary to allow only an international force under the supervision of the United Nations to remain in Afghanistan for five-six years to fight the terrorists jointly under a bipartisan agreement with the Afghan National Army; such an experience would also train and equip the Afghan Army for the future of the Country.
 - iv. Afghan National Army and Police should be reformed based on the former (1978) tradition of two years of “National Obligatory Service.”
 - v. Whereas security and stability are essential for implementing socio-economic-political programs. Therefore severe measures should be adopted to collect arms from armed civilians, as well as from (NGOs’s) and warlords.

The Government should declare and warn that all forms of arms, excluding small pistols and hunting guns, must be returned to the Government free of cost or in exchange for food, clothing, agricultural seeds, fertilizers or industrial tools; otherwise, the Government would use force to collect the arms from the public and those not cooperating would be punished.

In Kabul as well as other cities, arms should be collected from all civilians, warlords, Afghan and Non-Afghan institutions and NGO’s. The security of the towns, Government organizations, private institutions, foreign Embassies, Consulates, and commercial agencies should be guaranteed

by the joint U.N. and Afghan forces based on bilateral agreements. Parties not accepting the Government order should be seriously punished.

- vi. Appointing an authorized commission among experienced Afghan experts to draft five- five years developmental plans for 25 years with the cooperation of foreign experts.

Considering the socioeconomic-military and human resources conditions of the country and the priorities. This plan should be prepared within six to nine months to be submitted to foreign investors and international institutions to attract foreign financial and technical aid to reconstruct Afghanistan's infrastructure.

- vii. Appointing twenty scholars consisting of economic, military, social and political experts by free and secret voting from the members of the "Inter-Afghan National Conference" to be stationed at the United Nations in New York for five years. They will function as a bridge and liaison between the United Nations and the Government of Afghanistan for coordinating various functions.

- viii. Gradual coordination of the implementation of the process of democracy and the free market with the process of socioeconomic development and law enforcement in all Government and private sectors; searching for ways and means to attract and encourage the participation of Afghan societies in Government affairs, projects and in the process of reconstruction in particular.

- ix. Accepting the theory of creating government cooperatives to compete with the internal and external private sectors in matters such as the supply of food (i.e. tea, sugar, edible oil, benzine, gas, flour, and wheat) and reorganizing the old system of distributing "Coupons" to the Government employees, teachers, contract employees and military officers.

- x. Creating a reasonable policy for avoiding the cultivation, processing and illegal sale and trade of opium; creating work and employment for the peasants engaged in such matters; tracing and punishing internal and foreign heroin dealers; implementing heavy punishments like those in Saudi Arabia on the dealers; encouraging landowners to cultivate such substitute as saffron, cotton, sugar cane, beetroot, horticulture, raising livestock, poultry, ice-making factories in the main cities and simple ones in the villages; using solar energy and small generators for creating energy; giving long-term loans for the realization of those projects: establishing agricultural cooperatives and small factories for processing food items, fruits, candies and the like.

- xi. Researching on the claims of Afghanistan and the Russian Federation in connection to the former demand for the war compensation/reparation and the latter demand for the payment of the loans given to former puppet Governments and reaching a final solution under the auspices of the security council.

xii. Finding a solution to the problem of “Pashtunistan,” Pashtuns are our brothers sharing the same religion, language, culture and traditions; this land was separated from Afghanistan, and an imposed line was drawn to separate the two brothers.

However, we want today a choice of self-determination for the Pashtuns and Balouches, preserving the territorial integrity of Afghanistan. We want to resolve the problem of the Durand Line by peaceful negotiation with Pakistan with the participation of the representatives of Pashtuns and Balouches under the auspices of the United Nations.

xiii. A solid and final determination concerning amnesty or trial of the Afghan war criminals, violators of human rights and national traitors during the past thirty years.

xiv. Searching for practical ways and means for the return of Afghan refugees from Pakistan and Iran and their settlement in uncultivated lands owned by the Government; giving each family a piece of land to build a house; building markets, health clinics, schools, police and security, digging deep wells, installing small diesel generators, building small factories and industries, etc.

Under the supervision of the concerned ministry with the help of the world refugee and food organizations and initiating the program of work for food.

xv. Providing settlement for Afghan Nomads (Kouchees) in various parts of the country, considering social justice and their living conditions; selling public lands under favourable terms at affordable prices and long-term payments and issuing identification documents to the Nomads as a token to quit Nomadism.

xvi. Finding ways and means to financially support charity institutions such as (Small Islamic Bank) established in California, USA, (War-Torn Children and Ashiana) and the like for creating small industries like handmade items, arts and crafts and other low-priced items.

Such projects would benefit poverty, unemployment, orphans, widows and maimed persons to make them self-efficient and would attract national and international aid. (xvii) Drafting a socio-economic-political and military guideline valid for five years for the future Government of Afghanistan.

xvii. Making a firm decision concerning candidate Afghans who have double Nationality and legalization of dual Nationality for all Afghan refugees living in Europe, America, Australia and Elsewhere.

xviii. Revision of the Constitution, if necessary. (xx) Provisions for the election of the President of the Republic and his two assistants, twenty members of the cabinet, considering their educational background, practical experience, courage in decision making, piety and honesty. Selecting Provincial Governors from the 100 members of the “National InterAfghan Conference” by direct and secret voting from the three candidates for each position.

Giving preference to those Government candidates who are citizens of their respective provinces. For example, among the three candidates for the Governor of Herat, priority should be given to those who have better education, piety, courage, education, experienced and who are committed to implementing the policies of the central Government.

xix. Finally, all the decisions concerning the election and all the articles mentioned earlier about the functions and duties of the “National Inter-Afghan Conference” would be submitted to “Representative Loya Jirga” for ratification. Members of the “National Inter-Afghan Conference” and the “coordinating committee” will also participate in the “Representative Loya Jirga.”

xx. The First of Jouza 1388 (May 21, 2009) is the termination date of the Presidency of Mr. Karzai. On the completion of the two months emergency, “Representative Loya Jirga” would convene to ratify the decisions of the “National Inter-Afghan Conference.” Thus a new chapter would open in the history of Afghanistan.

xxi. After the ratification of the decisions of the “National Inter-Afghan Conference” by “Representative Loya Jirga,” the present National Assembly and Senate would be dissolved, except for the members of the cabinet (20) and provincial Governors and twenty Afghan experts for the United Nations. Members of the “Representative Loya Jirga” would replace those dissolved for five years; the new President would choose his “Selective Representatives” from the members of the “Inter-Afghan Conference” under article (84), item (3) of the constitution; provincial assemblies each would elect a new chairman.

xxii. At the “Representative Loya Jirga,” after the completion of the procedures for ratifying and dissolving during the two months of Hamal and Saour (March 21st - May 21st), the last day of Mr. Karzai’s Presidency is Saour 30th (April 21st), under article (61), chapter III of the constitution; on the first day of Djouza 1388 (May 22, 2009) Mr. Karzai will transfer the powers to the new leadership and administration in an official ceremony.

xxiii. Mention must be made that from among living abroad, those who are selected to go to Afghanistan as members of the “Representative Loya Jirga” they should serve with piety, honesty, responsibility, concern for human rights, love and devotion for Motherland, caring for national interests and not for personal interests;

In addition, they should persuade and encourage other Afghans living abroad to return and serve their country with whatever means available. It is hoped that the Afghan Government or International Institutions will provide for the livelihood of those returning to serve in Afghanistan.

Peace Proposal for Afghanistan.

I read your Final ASG Report and listened to the prepared Video; I was impressed. Therefore from the bottom of my heart congratulate you for the excellent and profound analysis of the situation in Afghanistan, especially in the last 19 years.

My Sad Memory from the Tragedy of September 11, 2001, 2001

After nine months of President George W. Bush in power, on September 9th, 2001, Ahmed Shah Masud was assassinated in Khwaja Bahauddin, Taloqan, Afghanistan; that puzzle wasn't solved yet. It was 7:00 a.m. in Vancouver, B.C. Canada, which was 10:00 a.m. in New York, and 7:00 p.m. in Dubai time; I was sleeping when the telephone bell rang; when I got up and picked up the telephone, my daughter Zeligay Ahmed was on the phone from Dubai.

She just said Daddy-Daddy get up and watch CNN when I ran down to the living room and turned on the TV, I saw an unbelievable tragedy and watched the WTC in New York burning down; the ashes covered the whole city, the fire workers and the people in the area covered with dust and ashes of the buildings, screaming, crying, running.

The people of the United States and the world were wondering what happened. And why did it happen? Why did the planes hit the buildings? And who is or who is behind all this inhuman act?

When I heard that was a terrorist act, it was unacceptable to me because, after the tragedy of crashing ill-fated Pan Am Flight 073 on September 5, 1986, in Karachi, in my letter dated September 8th, 1986, addressed to H.E. Mr. Javier Perez de Cuellar, United Nations Secretary-General, and copies were sent to the International Air Transportation Association (IATA). World leaders, I had to warn them that the emergence of terrorism on the surface and air is a hazardous phenomenon and someday would be out of control if the world, especially the world body 'U.N.' and the 'IATA' as well the members of the United Nations don't take strong and decisive action regarding the eradication of terrorism on the surface and in the air. But unfortunately, the U.N. and the world leaders didn't give any attention to my letter.

The IATA assured me in a letter dated October 1st, 1986, saying that “Terrorism is indeed a scourge that we must all combat, and you may be assured the airlines, governments, and airports are cooperating as never before to that end”(See Cry of Afghan page).

Therefore because the assurance was given to me from ‘IATA,’ I did not believe that would be the act of a person; there must be a group or an organization behind this massive inhuman act for a particular purpose or reason; I was kept asking myself the same question over and over,

Who did it? Why would he do that? Why did it happen right after Ahmed Shah Massud’s assassination on the 9th of September, 2001? Is there any connection between September 11 and September 9th happening? And many other questions.

Yet my questions were not answered; a few days after the September 11 tragedy President Bush and the key members of his administration forgot the 3000 innocent people buried under the rubbles of (WTC) the cry of their bereaved ones, the sorrow of Americans and the people of the world, above all his promises to American Nation and the people of the world during the first two, three days of the sad event happened.

They, as a bunch of experienced hunters, like before the tragedy of 9/11, sat in the White House and Pentagon to plan a hunting program for the weekend or later and decide where to go for hunting. And what to hunt?

This time was not the hunting of animals, birds or fishing. It was hunting the human to get the Oil of Iraq or going to Afghanistan to get the gas of Turkmenistan, as well as the opening of a new chapter for the globalization of war against self-created so-called “International terrorism” for implementing his and his predecessors forward policy in the world, predominantly Muslim countries after the defeat of Communism. In the end, once again.

I pray to our God almighty to have the place of all they have lost their precious life in that sad event in Heaven and their soul be in peace. – I express my most profound Sorrow and Condolence to all the bereaved families.

From:- *Conspiracies and Atrocities in Afghanistan, 1700-2014*(pages 521-522) conclude my cries with the following words, I would like to express with my most profound sorrow that my cries have not been virtual cries such as in my childhood to cry for as changing my wet diaper, feeding me, being too hot, or too cold, had a fever, pain or slapped or pinched by someone on my face or on my body, or not reaching my toys seeking help and etc., or in my adult life I have cried because the loss of my beloved ones in the family, instead all my letters and proposals were my silent cries means my deep internal cries by using pen and paper to express my appeals reflecting mine and my all Afghan, citizens desire to draw the attention of the world leaders including the United Nations, None Aligned movement, Islamic Conference and other world organizations to the crimes, crises, atrocities, destructions, replacing millions of my country men and women out of their beloved motherland such as me and my immediate and extended families members scattered in different parts of the world or displaced inside the country from one province to other and the injustices happening in my beloved motherland in last 44 years

since the bloody coup of Hafizullah Amin on April 27, 1987, and murdering the first president of Republic of Afghanistan late Sardar Mohammad Daud Khan, and all his family including his brother Sardar Mohamad Naim Khan, on early morning of April 28, and later in Dec 1979, the open military invasion of the then Soviet Union and installing Babrak Karmal As their Puppet and lost our freedom, independence and National sovereignty. Indeed that was an unbelievable, unfortunate tragedy in the history of Afghanistan; I believed that only the then Soviet Union and Communists were the cruellest atrocities in the world, though, from the pages of the past, history I knew that the non-Communist world was beating up the drum of Communism-O-Phobia since the October Revolution in 1917 in Russia.

However, still, I was very naïve. I wasn't thinking that the Americans and their western allies were beating up the drum of freedom, justice, human rights, and democracy.

They would be worse than the Soviet Union; actually, I admit that I was wrong. It was different. They were too bloodsuckers of the poor but rich under the ground. They were working together to defeat Russia and Communism in the blood of my Afghan citizens, to reach their aims no matter how much it cost them and Afghans, not letting Russia go of the Indian Ocean; after that USA and British invaded Afghanistan on October 7, 2001, on the pretext of freedom and democracy and brought their puppets Hamed Karzai and Dr. Ashraf Ghani one after the other the irony was that both adversaries used my egoistic ignorance of the enemies' conspiracies.

They became the hired servants of the enemies and destroyed their beloved motherland, and lost the independence, national integrity and territorial integrity of the strongest country in the region. Since the defeat of the Soviet Union and Communist the western world using Islamic extremism to reach out to Russia, China, Central Asia and Iran, and in the meantime beating up the Islamophobia Phenomena by their servants, especially Pakistan, so-called Mujahideen, Taliban, Al Qaida and ISIS to destroy Islam on the surface of the earth under the leadership of ISI of Pakistan and bringing the Taliban into power in Afghanistan again. Therefore, the task of my cries in the last 44 years is not over yet; as long as I am alive, my heart will be beating harder and harder for the well-being of my all Afghan brothers and sisters. (Afghan Nation) Though my half heart is not functioning correctly, and I am 84, I will never stop my cries for the cause of my motherland, and I will continue my cries for freedom, independence and national unity. Social justice democracy, to get back the national sovereignty and territorial sovereignty of my beloved motherland Afghanistan in non-violent ways, is my promise; I am sure my heroic Afghan Nation would do the same. God help us.



CONCLUSION

I conclude my cries with an important message. I would like to emphasize and express with my most profound sorrow that my cries have not been empty, such as the cries of a baby with a wet diaper, an empty stomach, or a fever. Similarly, only I have cried or shed tears in my adult life for the loss of my beloved ones in the family. Instead, all my letters and proposals were my silent cries, my deep internal cries using pen and paper to express my appeals and plead with the world leaders to bring an end to the massacre in my motherland to have peaceful, free, independent and democratic Afghanistan.

My cries reflect the desire of all Afghan citizens to draw the attention of the world leaders, including the United Nations, Nonaligned Movement, Islamic Conference and other world organizations, to the crimes, crises, atrocities, and destruction in Afghanistan.

They are the cries of millions of my countrymen and women now living away from their beloved motherland, which includes me and my immediate and extended family members scattered in different parts of the world. Some were even displaced inside the country from one province to another.

They are the cries against the injustices happening in my beloved motherland in the last 44 years since the bloody coup of Hafizullah Amin on April 27, 1987, and the murder of the first president of the Republic of Afghanistan, Sardar Mohammad Daud Khan, and all his family. It included his brother Sardar Mohamad Naim Khan, on the early morning of April 28, followed later in Dec 1979 by the open military invasion of the Soviet Union, who eventually installed Babrak Karmal as their puppet leader. It resulted in the loss of our freedom, independence and national sovereignty.

Indeed that was an unbelievable, unfortunate tragedy in the history of Afghanistan. I believed that only the Soviet Union and Communists were capable of the cruellest atrocities in the world, though, from the pages of history, I know that the non-communist world has been beating the drum of Communism-O-Phobia since the October Revolution in 1917 in Russia.

Your Excellency.

They have closed all universities and high schools to women, preventing them from pursuing further education. They have also banned women from working in the Afghan government and foreign NGO agencies. Many of these women are the sole breadwinners of their households.
